TO ALL HOLDERS OF CLAIMS ENTITLED TO VOTE ON THE PLAN:

BJ Services, LLC and its affiliated debtors and debtors in possession (collectively, the "<u>Debtors</u>")¹ each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the Southern District of Texas (the "Court") on July 20, 2020.

You have received this letter and the enclosed materials because you are entitled to vote on the Plan included in the *Debtors' Combined Disclosure Statement and Joint Chapter 11 Plan* (as may be amended, supplemented, or modified from time to time, the "Combined Plan and Disclosure Statement," and the "Disclosure Statement" or "Plan," as applicable). On September 11, 2020, the Court entered an order (the "Disclosure Statement Order"): (a) authorizing the Debtors to solicit acceptances for the Plan; (b) conditionally approving the Disclosure Statement as containing "adequate information" pursuant to section 1125 of the Bankruptcy Code; (c) approving the solicitation materials and documents to be included in the solicitation packages (the "Solicitation Packages"); and (d) approving procedures for soliciting, receiving, and tabulating votes on the Plan, and for filing objections to confirmation of the Plan and final approval of the Disclosure Statement.

You are receiving this letter because you are entitled to vote on the Plan. Therefore, you should read this letter carefully and discuss it with your attorney. If you do not have an attorney, you may wish to consult one.

In addition to this cover letter, the enclosed materials comprise your Solicitation Package, and were approved by the Court for distribution to Holders of Claims in connection with the solicitation of votes to accept the Plan. The Solicitation Package consists of the following:

- a. a Ballot, together with detailed voting instructions and a pre-addressed, postage prepaid return envelope;
- b. this letter;

BJ Services, LLC (on behalf of itself and each of the other Debtors) has approved the filing of the Plan and the solicitation of votes to accept the Plan. The Debtors believe that the acceptance of the Plan is in the best interests of their estates, Holders of Claims, and all other parties in interest. Moreover, the Debtors believe that any alternative other than Confirmation of the Plan could result in extensive delays and increased administrative expenses, which, in turn, likely would result in smaller distributions (or no distributions) on account of Claims asserted in these chapter 11 cases.

The Debtors strongly urge you to properly and timely submit your Ballot casting a vote to accept the Plan in accordance with the instructions in your Ballot.

The Voting Deadline is October 6, 2020 at 4:00 p.m. prevailing Central Time.
