DECLARATION OF RICHARD NGUYEN

- I, Richard Vu Nguyen, hereby declare as follows:
- 1. I am a defendant in the above entitled action. I formerly ran and operated NTV Financial Group, Inc., until the appointment of Receiver Jeffrey Brandlin.
- 2. I make this declaration in support of Opposition to Ex Parte Application for Order to Show Cause Why Richard Nguyen and Mai Do Should Not be Held in Civil Contempt. I have personal knowledge of the facts stated herein and if called as a witness I would and could competently testify to the matters stated herein.
- 3. On June 26, 2019, I was served with the summons and complaint in this lawsuit. The documents served on me were stuffed in a full banker's box with thousands of pages of documents. I did not understand the legal documents.
- 4. On July 15, 2019, I provided my attorney with my list of assets, including real property and personal property.
- 5. At the time I provided my attorney with my list of assets, I had fully disclosed all accounts that I believed were subject to the Preliminary Injunction Order. The Receiver has mischaracterized my cooperation and candor with the Court on disclosure of my assets.
- 6. The Citibank account ending 7824 identified by the Receiver I opened after submitting my List of Assets. Because of the asset freeze over my business and personal accounts, I needed an account to handle the banking transaction of my construction business. This business is unrelated to the allegations in the lawsuit and I had a good faith belief I did not need to disclose.
- 7. The Fidelity account ending 8347 identified by the Receiver had no trading activity and no monies. In fact, it had an account value of \$1.24 on June

30, 2109. Due to the inactivity and effectively zero funds, I had a good faith belief this account did not need to be disclosed.

Based upon the foregoing, I did not and do not believe that I have 8. taken any action with the intent to violate the Court Order.
