RECITALS

1. By order entered on June 14, 2019 [Docket No. 15], as amended by a minute order entered on June 24, 2019 [Docket No. 21], the Court appointed the Receiver as the temporary receiver of NTV Financial and its subsidiaries and affiliates and all bank accounts through which investor funds flowed.

2. Pursuant to a stipulation of the parties, by order entered on July 3, 2019 [Docket No. 25], the Court issued a preliminary injunction and appointed the Receiver as the permanent receiver, giving him control over all assets of NTV, among other things.

3. NTV Financial has a website at www.ntvfinancial.com that is hosted by GoDaddy.com, LLC ("GoDaddy"). Consistent with the order appointing him, the Receiver intends to redirect this website to one set up by the Receiver that appears at www.donlinrecano.com/NTVFinancial. In order to accomplish this, GoDaddy is requiring a specific Court order that identifies the website addresses.
