PLEASE TAKE FURTHER NOTICE that the deadline for the Debtor, the Committee, and any other party-in-interest to respond to any objections to the *Joint Chapter 11 Plan of Orderly Liquidation* (the "<u>Plan</u>") [Dkt. No. 698] has been extended to **5:00 p.m. on July 24, 2018** (the "<u>Response Deadline</u>").

PLEASE TAKE FURTHER NOTICE that responses or objections, if any, to the relief sought in the Deadlines or the Response Deadline must be in writing, conform to the Federal Rules of Bankruptcy Procedure, the Local Rules of the Bankruptcy Court, and the procedures described in the *Order Establishing Certain Notice and Case Management Procedures* [Dkt. No. 49] (the "Case Management Order") entered by the Bankruptcy Court on July 18, 2017. Any responses or objections shall be served on the Master Service List in an accordance with the Case Management Order.

Any responses or objections must be filed and served so as to be received no later than the Deadlines or the Response Deadline. If you mail your request or response, you must mail it early enough so the parties will receive it on or before the Deadlines or the Response Deadline. If you or your attorney do not take these steps, the Court may decide that you do not oppose the relief

sought in the Deadlines or the Response Deadline and may enter an order granting that relief.
