PRELIMINARY LIQUIDATION PLAN OF ROBERT MOSIER, COURT-APPOINTED RECEIVER
[No hearing required]

Pursuant to Section XIII of the Order Appointing Receiver (the "Receiver Order"), Robert P. Mosier, the Court-appointed receiver (the "Receiver"), submits the following Preliminary Liquidation Plan to apprise the Court of the progress made thus far, the issues that need to be resolved to continue to make progress, and the anticipated next steps.

## I. SCOPE OF THE RECEIVERSHIP ESTATE

Pursuant to the Receivership Order, the Receiver was authorized and directed to take control of the assets of Kent R.E. Whitney, David Parrish,

The Church for the Healthy Self aka CHS Trust ("CHS Trust"), and CHS Asset Management, Inc. (together, the "Receivership Defendants"), as well as of their affiliates. In March 2018, iCare Financial Solutions, Inc. ("iCare"), an entity owned by Ngoc Ha Nguyen ("Ha Nguyen"), notified its investors that it was merging with CHS Trust. It appears from the Receiver's review of the books and records that this merger was implemented, and there were significant transfers between CHS Trust, iCare, and Ha Nguyen based on the evidence. The Receiver believes that iCare and Ha Nguyen should be considered to be affiliates of CHS Trust. He also believes that an account belonging to a restaurant believed to be owned by Ha Nguyen should be determined to be within the scope of the Receivership Estate because it received a significant amount of funds indirectly from CHS Trust. Indeed, the preliminary injunction entered by the Court included in its scope bank accounts belonging to iCare and Ha Nguyen. However, in order to avoid any ambiguity, the Receiver believes that Ha Nguyen and iCare should be explicitly made part of the Receivership Estate. If the Securities and Exchange Commission does not seek this relief in the near future, then the Receiver intends to file either a motion to expand the scope of the Receivership Estate or a petition for further instruction from the Court.

The Receiver has also traced some funds into an account in the name of 2DC Partners, LLC dba CHS Asset Mgt or CHS and is in the process of obtaining turnover of the funds, though the balance that was frozen is believed to be less than $\$ 1,500$.

## II. PERSONAL PROPERTY

As set forth in the prior status reports, after the Receiver's appointment on March 14, 2019, he and/or his agents along with representatives of the SEC and the FBI went to addresses associated with the Receivership

Defendants to change the locks and gain control over those locations and to take control of assets and books and records. Specifically, the Receiver went to residences at 118 Garnet Avenue, Newport Beach, CA and 1000 San Joaquin Plaza \#6309, Newport Beach CA, and to the following office locations: (1) the CHS Trust office at 14082 Magnolia St., Westminster, CA 92683; (2) a former CHS Trust office on Bolsa Avenue in Westminster, CA; (3) a CHS Trust address at 141 West Jackson Blvd., Suite 400, Chicago, II 60604; (4) an office address for iCare located at 2114 Senter Rd., Suite 12, San Jose, CA 95112; and (5) the Church for the Healthy Self address at 3131 McKinney Avenue, Suite 600, Dallas, Texas 75204. The Receiver had the locks changed at the residences and at the CHS Trust office on Magnolia Avenue in Westminster, although the Receiver has since returned possession of the Magnolia Avenue location to the landlord.

At the residential properties, the Receiver took possession of various personal property, including jewelry, clothing, computers, sports equipment, and three cell phones. The Receiver located \$53,037 in cash and deposited that cash. At the office locations, the Receiver took possession of office equipment, books and records, and computer records. He had the computers imaged and reviewed, and the books and records are in the process of being reviewed for information that may assist the Receiver with the identification and location of assets for the Receivership estates.

Because the Receiver Order authorized the Receiver to liquidate personal property in the manner that the Receiver believed was most beneficial to the Receivership Estate, the Receiver retained Tranzon Asset Strategies ("Tranzon") to conduct an online auction of the personal property, including a Bentley automobile, that was seized at the residential and office locations. The auction was conducted in late April and generated $\$ 54,194.94$ for the benefit of the Receivership Estate after the payment of
costs associated with the sale. A copy of the report of the auction is attached as Exhibit "1."

The Receiver also took possession of a Mercedes and a BMW. Both are in Tranzon's possession now and will be liquidated shortly. There are five other cars believed to be under Mr. Whitney's control, but the cars are older makes believed to be in the possession of third parties and do not appear to be worth the cost that would be incurred locating them, taking possession of them, and then selling them.

There are a number of items that were confiscated by the Receiver when he visited the various locations referenced above that did not sell in Tranzon's auction and where the cost to sell the items is expected to exceed any benefit generated. These items range from clothing to a fake Rolex watch. As authorized by the Order Granting Motion of Receiver, Robert P. Mosier, for Order in Aid of Receivership (the "Abandonment Order"), the Receiver intends to give notice to either Mr. Whitney or Mr. Parrish, depending on which home the items were confiscated from, that they have five days to retrieve the property and, if they fail to make arrangements to retrieve the items, the Receiver will donate the useful items to Goodwill and dispose of the rest. At least one third party with clothing that was removed from one of the residences and that was not sold by Tranzon has retrieved her items from storage and there may be one or two more third parties who also retrieve clothing items. The small amount of personal property at the Westminster office that was not sold as part of the auction was abandoned to the landlord when the premises were returned to it.

The Receiver has also identified some partnership units that Church for the Healthy Self holds in a publicly traded limited partnership and expects to retain a broker to assist in their liquidation. The units are expected to be worth approximately \$10,000.

## III. BANK ACCOUNTS

## A. Funds Recovered by the Receiver

Upon his appointment, both the Receiver and the SEC sent letters to all financial institutions believed to be holding accounts for the Receivership Defendants to give them notice of the asset freeze. This included accounts in the name of iCare, Ha Nguyen, and Crawfish Lovers and Cajun Seafood, a restaurant that is believed to be owned by Ms. Nguyen and which received funds traceable to CHS Trust. Accounts in the name of these three entities are referred to as the "iCare Accounts." The Receiver has instructed financial institutions holding funds in the name of the Receivership Defendants to turn over the funds in their possession and has collected approximately $\$ 231,680$ thus far. The Receiver has an additional $\$ 742,527.84$ in funds in the iCare Accounts frozen, but has not yet taken possession of the funds pending further instruction from the Court. The Receiver expects that the scope of the Receivership Estate will be expanded to explicitly include iCare and Ha Nguyen and the account belonging to the restaurant. That expansion will either be on motion of the Securities and Exchange Commission or the Receiver.

## B. Funds Seized by the Federal Bureau of Investigation Prior to the Receiver's Appointment

Prior to the commencement of this action by the Securities and Exchange Commission, the Federal Bureau of Investigation obtained criminal seizure warrants over funds in accounts belonging to CHS Trust and CHS Asset Management, Inc., seizing approximately $\$ 4.4$ million. Initially, the Receiver was informed by the FBI that the funds were expected to be turned over to and administered as part of the Receivership Estate. However, the U.S. Attorney's Office recently informed counsel for the Receiver that it does not intend to do that and instead intends to internally
administer the funds through its own remission process. The Receiver believes that it would be more efficient for these funds to be administered as part of the Receivership Estate because there is a formal claims process that is judicially supervised. It is presently unclear how this issue will be resolved.

## IV. REAL PROPERTY

The Receiver is analyzing the benefit of administering a rental property owned by Mr. Parrish located at 45 East $23^{\text {rd }}$ St., Chicago, IL. If the property is worth more than the mortgage and any other liens against it, then the Receiver will comply with 28 U.S.C. § 2001 and seek a further Court order. If the cost to administer it would exceed the benefit, then the Receiver will abandon it in accordance with the Abandonment Order.

The Receiver has determined that Mr. Whitney holds title to two pieces of raw land: one in the Santa Clarita area of California and the other in Mississippi. The purchase price that he caused to be paid for these parcels is minimal, and the Receiver believes that it is unlikely that the parcels will be worth enough to be administered, but he is still collecting information before making a final determination. If the Receiver decides not to administer these parcels, then he will abandon them in a manner consistent with the Abandonment Order.

In addition, there is at least one property that appears to have been conveyed to CHS Trust by a defrauded investor who did not intend to permanently convey title to CHS Trust. If the Receiver is able to determine that the grantor was deceived, because real estate is identifiable and because of the equities, he would intend to seek an order of this Court authorizing him to quitclaim the property(ies) back to the grantor. The Receiver is so far aware of one property where title was actually transferred
and a second where it does not appear that the deed was recorded, although it was signed.

## V. POTENTIAL LITIGATION CLAIMS

Because the receivership has only been pending since March 14, 2019, the Receiver is in the process of analyzing potential claims against various parties. At a minimum, he anticipates that he will seek recovery of sums investors received in excess of the principal amount of their investment and of certain fraudulent transfers made by the Receivership Defendants, including the payment of commissions on money brought in. He anticipates retaining a law firm as litigation counsel to pursue these claims on a contingency fee basis. The Receiver is also analyzing whether any financial institutions have liability for the fraud that occurred here and, if it is determined that such claims have merit, the Receiver may jointly prosecute such actions with the investors, again using contingent-fee counsel. As directed by the Receiver Order, the Receiver will seek Court approval before commencing any such actions.

The Receiver is also evaluating whether it is in the best interest of the Receivership Estate to seek civil contempt charges against Mr. Whitney and Mr. Parrish and certain third parties who received notice of the Receiver Order but failed to comply with the accounting and cooperation requirements of the Receiver Order.

## VI. CLAIM PROCESS

As explained in the Receiver's status reports, one of the bigger challenges has been the compilation of a list of the investors because Mr. Whitney has not cooperated at all and Mr. Parrish has not materially cooperated. In addition, the Receiver has been unable to get in contact with
several of the key employees who managed or had access to the database of investors and is not certain the information he was able to access was entirely accurate. However, after reviewing statements and crossreferencing them with the lists of investors he was able to access, the Receiver has thus far compiled a list of 442 investors who purportedly own 541 accounts. This list is not yet complete and verification is ongoing.

The Receiver is in the process of completing his calculations of each investor's "net investment," which is the amount that they actually invested, less any distributions made to them or on their behalf and not including any interest income. Once that is complete and once the Court has clarified that iCare is explicitly a part of the Receivership Estate, the Receiver intends to seek Court approval of his proposed claim procedure under which the Receiver will send a letter to each investor notifying them how the Receiver has calculated their claim and what the amount of their net investment is based on the books and records. If the investor disagrees, the Receiver proposes that they have an opportunity to submit a claim form to the Receiver, together with supporting documentation. If the Receiver agrees with the claim, then no further action will be necessary. If the Receiver disagrees, then he will seek an order of the Court resolving the issue. The Receiver believes that investors should have sixty days to return their claim form and documentation to the Receiver and that if they fail to submit a timely claim, they should be barred from doing so. This is necessary to enable the Receiver to administer the Receivership Estate timely. As part of this process, the Receiver also intends to seek a Court order giving the defrauded investors priority in distributions over other creditors of the

Receivership Estate.
