**NOTICE OF BAR DATE FOR
FILING INITIAL ADMINISTRATIVE CLAIM REQUESTS**

TO: ALL POTENTIAL HOLDERS OF ADMINISTRATIVE CLAIMS

PLEASE TAKE NOTICE OF THE FOLLOWING:

On May 14, 2008, the United States Bankruptcy Court for the Eastern District of Michigan (the "Court") approved an order (Docket No. 1322) (the "Administrative Claims Bar Date Order") in the above-captioned chapter 11 cases establishing **June 30, 2008 at 5:00 p.m. (Eastern)** as the deadline (the "Initial Administrative Claims Bar Date") for holders of Administrative Claims (as defined below) in the chapter 11 cases of the above-captioned debtors and debtors in possession (the "Debtors") to file requests for payment of such claims. Except as described below, the Administrative Claims Bar Date Order requires all persons or entities holding an Administrative Claim (as defined in sections 101(5) and 503(b) of 11 U.S.C. §§ 101-1532 (the "Bankruptcy Code")), including, without limitation, any administrative claim (an "Administrative Claim") by the current and former officers and directors of the Debtors, first arising from and after February 1, 2008 (the "Petition Date") through and including May 30, 2008, to file a request for payment of such Administrative Claim (an "Administrative Claim Request") on or before the Initial Administrative Claims Bar Date.

Exclusion of 503(b)(9) Administrative Claimants From Administrative Bar Date. Any holder of a 503(b)(9) administrative claim (each a "503(b)(9) Holder"), which claim is required to be filed by May 30, 2008 (the "503(b)(9) Bar Date"), pursuant to order of this Court and notice provided to such 503(b)(9) Holders, is not permitted after the 503(b)(9) Bar Date to file an Administrative Claim request for such claim under Bankruptcy Code section 503(b)(9). As set forth in the notice of the 503(b)(9) Bar Date, any person or entity holding a claim pursuant to Bankruptcy Code section 503(b)(9) that fails to file a claim request on or before May 30, 2008, is forever barred and estopped from asserting a

claim pursuant to Bankruptcy Code section 503(b)(9) against the Debtors, their estates, or the property of any of them, absent further order of the Court.

PERSONS OR ENTITIES WHO MUST FILE AN ADMINISTRATIVE CLAIM REQUEST

Bankruptcy Code section 503(a) requires all persons and entities holding an Administrative Claim first arising from and after the Petition Date through and including May 30, 2008, including, without limitation, any administrative claim by the current and former officers and directors of the Debtors, current and former employees of the Debtors, indemnitees, individuals, partnerships, corporations, estates, trusts, indenture trustees, unions, governmental units, and non-Debtor parties to any unexpired executory contracts or leases (collectively the "Agreements") with any of the Debtors who allege that any amounts arising under any of the Agreements from and after the Petition Date are due, owing and unpaid as of May 30, 2008, be required to file a request for payment of such Administrative Claim on or before the Initial Administrative Claims Bar Date.

Bankruptcy Code section 101(5) defines "Claim" to mean:

- (A) right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured, or unsecured; or
- (B) right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured or unsecured.

11 U.S.C. § 101(5).

CONSEQUENCES OF FAILURE TO FILE ADMINISTRATIVE CLAIM REQUEST

ANY PERSON OR ENTITY HOLDING AN ADMINISTRATIVE CLAIM THAT FAILS TO FILE AN ADMINISTRATIVE CLAIM REQUEST ON OR BEFORE THE INITIAL ADMINISTRATIVE CLAIMS BAR DATE SHALL BE FOREVER BARRED AND ESTOPPED FROM ASSERTING AN ADMINISTRATIVE CLAIM AGAINST THE DEBTORS, THEIR ESTATES, OR THE PROPERTY OF ANY OF THEM.

TIME AND PLACE FOR FILING ADMINISTRATIVE CLAIM REQUESTS

For any Administrative Claim Request to be timely and properly filed, a person or entity holding an Administrative Claim must submit a signed original Administrative Claim Request asserting such Claim, together with accompanying documentation, to Donlin, Recano & Company, Inc. ("Donlin") at either of the following addresses:

Each Administrative Claim Request must be delivered to and received by Donlin no later than 5:00 p.m., Eastern Time on the Initial Administrative Claims Bar Date. Any Administrative Claim Request may be submitted in person or by courier service, hand delivery or mail addressed to Donlin at the foregoing specified address. **Any Administrative Claim Request submitted by facsimile will not be accepted and will not be deemed filed until such Administrative Claim Request is submitted by one of the methods described in the foregoing sentence.** Any Administrative Claim Request will be deemed filed only when actually received by Donlin. If you wish to receive acknowledgment of Donlin's receipt of your Administrative Claim Request, you must also submit a copy of your original Administrative Claim Request and a self-addressed, stamped envelope. **If you wish to assert Administrative Claims against more than one Debtor, you must file a separate Administrative Claim Request in the case of each Debtor against which you believe you hold a claim.**

**PERSONS OR ENTITIES WHO NEED NOT FILE
ADMINISTRATIVE CLAIM REQUEST**

The following entities are not at this time required to file an Administrative Claim Request:

1. Entities that do not have an Administrative Claim against any of the Debtors under Bankruptcy Code sections 101(5) and 503. The fact that you received this Notice does not mean that you have such a claim.
2. Parties that have already properly filed an Administrative Claim Request with the Court or Donlin that clearly sets forth that such party is asserting an Administrative Claim.
3. Parties whose Administrative Claim has been previously allowed by order of the Court.

4. Debtors holding an Administrative Claim against another Debtor.

5. Professional advisors (i.e., attorneys, financial advisors, accountants, claims agents) retained by the Debtors or the Creditors' Committee under Bankruptcy Code sections 327, 328 or 1103 and whose Administrative Claim is for services rendered and reimbursement of expenses in these Chapter 11 cases, provided further that any professional retained by court order under Bankruptcy Code section 327, 328 or 1103 need not submit a claim for reimbursement of any claim under section 503(b) for any period subsequent to the Petition Date until such professional files a final fee application in connection with these cases.
