**NOTICE OF FILING OF FURTHER SUPPLEMENTS TO THIRD AMENDED JOINT
PLAN OF REORGANIZATION OF QUEBECOR WORLD (USA) INC. AND
CERTAIN AFFILIATED DEBTORS AND DEBTORS-IN-POSSESSION RELATING
TO THIRD SUPPLEMENTAL EXHIBITS REGARDING EXECUTORY
CONTRACTS AND UNEXPIRED LEASES**

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. On May 18, 2009, the Bankruptcy Court entered an Order (Docket No. 1666) (the “Disclosure Statement Order”) approving, among other things, certain procedures with respect to the treatment of executory contracts and unexpired leases of the above-captioned debtors and debtors in possession (collectively, the “Debtors”) under their Third Amended Joint Plan of Reorganization of Quebecor World (USA) Inc. and Certain Affiliated Debtors and Debtors-in-Possession (as it may be amended or modified, the “Plan”). Capitalized terms not otherwise defined herein have the meanings given to them in the Plan.

2. On July 2, 2009, this Court entered the Findings of Fact, Conclusions of Law and Order Confirming the Third Amended Joint Plan of Reorganization of Quebecor World (USA) Inc. and Certain Affiliated Debtors and Debtors-in-Possession, dated July 1, 2009, as modified (the “Confirmation Order”) (Docket No. 1802).

3. On June 9, 2009, June 30, 2009 and July 15, 2009, pursuant to the Disclosure Statement Order and the Plan, the Debtors filed certain Exhibits and supplemental and/or modified Exhibits (the “Supplemental Exhibits”) to the Plan, including, but not limited to, the following:

Exhibit 7.1 Non-Exclusive Schedule of Executory Contracts and Unexpired Leases to be Assumed (the “Assumption Exhibit”).

Exhibit 7.5 Non-Exclusive Schedule of Executory Contracts and Unexpired Leases to be Rejected (the “Rejection Exhibit”).

4. Pursuant to the Disclosure Statement Order and the Plan, the Debtors reserved their rights to modify such Exhibits after their initial filing. See Plan, Article 7.1. and 7.5; and Disclosure Statement Order ¶ V.27.b.

5. Attached hereto as Annex 1 is a further supplement to the Assumption Exhibit (the “Third Supplement”). The Third Supplement identifies (a) additional agreements subject to assumption, rejection or assignment pursuant to the Disclosure Statement Order and the Plan; and (b) agreements that were identified on the prior Exhibits where information concerning their assumption, assignment or rejection has been modified or corrected.

6. The Debtors reserve their rights to further modify such Third Supplement, any other Supplemental Exhibits or Exhibits pursuant to the Disclosure Statement Order and the Plan.
