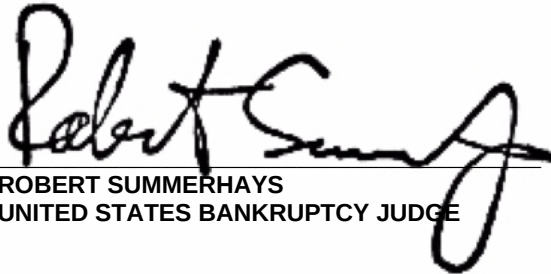

**ORDER ESTABLISHING BAR DATES FOR FILING PROOFS OF CLAIM AND
INTERESTS AND APPROVING NOTICE PROCEDURES**

Considering the Motion for an Order Establishing Bar Dates for Filing Proofs of Claim and Interests and Approving Notice Procedures (“Motion”) filed by Rooster Energy, Ltd., Rooster Petroleum, LLC, Rooster Oil & Gas, LLC, Probe Resources US Ltd., Cochon Properties, LLC, and Morrison Well Services, LLC (collectively the “Debtors”),

IT IS HEREBY ORDERED THAT:

1. The Motion be and is hereby granted.

2. All persons, corporations, partnerships, limited liability companies and all other entities, including governmental units, in these proceedings, including, without limitation, each individual, partnership, joint venture, corporation, limited liability company, estate, and/or trust that asserts an unpaid claim (as defined in the Bankruptcy Code) against Debtors, including, but not limited to, claims for taxes, accounts payable, alleged torts, and/or arising from pre-petition contracts, leases or agreements with Debtors, that arose prior to Debtors' Petition Date, regardless of whether such claim is contingent, disputed, inchoate or unliquidated, or any holder of a claim listed in Debtors' schedules or amended schedules of liability (collectively, the "Schedules") under the classification of "disputed," "contingent," and/or "unliquidated" that contests such classification, are required to file a written proof of claim.

3. November 28, 2017 is established as the bar date for the filing of proofs of claim for general unsecured claims against Debtors by all persons, corporations, partnerships, limited liability companies and all other entities, except for governmental units, (the "GUC Bar Date"). Any proof of claim filed by a non-governmental creditor or person in interest after November 28, 2017 will be disallowed.

4. November 28, 2017 is established as the bar date for the filing of applications for allowance of administrative claims in excess of \$50,000.00 incurred prior to November 28, 2017, 2017 against Debtors by all persons, corporations, partnerships, limited liability companies and all other entities, except for governmental units (the "Initial Administrative Claims Bar Date"). Any applicable administrative expense claim of a non-governmental creditor or person in interest for which a proof of claim was filed or for which an application for allowance of administrative

expense claim was not filed on the docket of these Cases by the Administrative Claims Bar Date will be disallowed.

5. November 28, 2017 is established as the bar date for the filing of proofs of claim for priority claims (other than administrative claims) against Debtors by all persons, corporations, partnerships, limited liability companies and all other entities, except for governmental units, (the “Priority Claims Bar Date”). Any proof of claim filed by a non-governmental creditor or person in interest after November 28, 2017 will be disallowed.

6. November 29, 2017 is established as the bar date for the filing of proofs of claim against Debtors by all governmental units (the “Governmental Unit Bar Date”). Any proof of claim filed by a governmental unit after November 29, 2017 will be disallowed.

7. Notwithstanding anything to the contrary above, herein, in the Motion, or in the Notice of Bar Date, the Initial Administrative Claims Bar Date, the Priority Claims Bar Date, and the GUC Bar Date shall not apply to any and all administrative and priority claims of the Debtors owed to (i) Angelo, Gordon Energy Servicer, LLC, as administrative agent and collateral agent on behalf of itself and the holders of secured notes (the “Holders”) issued pursuant to the Note Purchase Agreement, dated as of November 17, 2014 and amended and restated as of June 25, 2015 and (ii) the Holders.

8. Debtors are hereby authorized and directed to mail the Notice of Bar Date attached hereto as Exhibit A-1 together with a Proof of Claim Form to all parties listed on the mailing matrix maintained by the Court.

9. Debtors are hereby further the Debtors are authorized and directed to publish notice attached hereto as Exhibit A-2 in The Houston Chronicle, The Times-Picayune, and The Advocate newspapers in their respective Wednesday and Sunday editions.
