**TO: ALL ENTITIES WHO MAY HAVE AN ADMINISTRATIVE EXPENSE
ARISING UNDER SECTION 503(b) OF THE BANKRUPTCY CODE AGAINST
TRIAD GUARANTY INC.**

PLEASE TAKE NOTICE THAT:

1. On June 3, 2013, Triad Guaranty Inc, the debtor and debtor-in-possession in the above-captioned case, filed a petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.* (the “Bankruptcy Code”) in the United States Bankruptcy Court for the District of Delaware.

**DEADLINE FOR FILING ADMINISTRATIVE EXPENSE CLAIMS AGAINST
TRIAD GUARANTY INC.**

2. Pursuant to an order of this Court entered September 6, 2017, [D.I. 519] (the “Interim Administrative Bar Date Order”), the deadline for all persons and entities (including, without limitation, individuals, partnerships, governmental units, joint ventures, corporations, estates, and trusts) to file a request for payment (a “Request”) of an administrative expense against any Debtor under Bankruptcy Code section 503(b) arising on or before the date of entry of this Order (an “Administrative Expense Claim”)² is **October 6, 2017 at 4:00 p.m. (prevailing Eastern Time)** (the “Interim Administrative Bar Date”).

¹ The last four digits of the Debtor’s federal taxpayer identification number are 8519. The location of the Debtor’s headquarters and the Debtor’s service address is 1900 Crestwood Blvd., Birmingham, AL 35210.

² To the extent any portion of the Administrative Expense Claim has previously been satisfied by the Debtor, such amount should not be included in the Request.

3. THE FACT THAT YOU HAVE RECEIVED THIS NOTICE DOES NOT MEAN THAT YOU HOLD A CLAIM AGAINST THE DEBTOR OR THAT THE DEBTOR OR THE COURT BELIEVES THAT YOU HOLD A CLAIM AGAINST THE DEBTOR. YOU SHOULD NOT FILE A REQUEST IF YOU DO NOT HOLD AN ADMINISTRATIVE EXPENSE CLAIM AGAINST THE DEBTOR.

**CONSEQUENCES OF MISSING THE DEADLINE
FOR FILING ADMINISTRATIVE EXPENSE CLAIMS**

4. ANY PERSON OR ENTITY HOLDING AN ADMINISTRATIVE EXPENSE CLAIM THAT FAILS TO FILE A REQUEST ON OR BEFORE THE INTERIM ADMINISTRATIVE BAR DATE SHALL NOT BE ENTITLED TO RECEIVE ANY DISTRIBUTION IN THIS CHAPTER 11 CASE ON ACCOUNT OF SUCH ADMINISTRATIVE EXPENSE CLAIM OR RECEIVE FURTHER NOTICES REGARDING SUCH ADMINISTRATIVE EXPENSE CLAIM.
