

GLOBAL NOTES REGARDING VETERINARY CARE, INC. ET AL SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENTS OF FINANCIAL AFFAIRS

The Schedules of Assets and Liabilities (the "Schedules") and the Statements of Financial Affairs (the "Statements," and collectively with the Schedules, the "Schedules and Statements") filed by Veterinary Care, Inc. and TVET Management, LLC (collectively the "Debtors"), in the United States Bankruptcy Court for the Southern District of Texas (the "Bankruptcy Court"), were prepared pursuant to section 521 of title 11 of the United States Code (the "Bankruptcy Code") and Rule 1007 of the Federal Rules of Bankruptcy Procedure by management of the Debtors and are unaudited. While the Debtor's management has made every reasonable effort to ensure that the Schedules and Statements are accurate and complete, based upon information that was available to them at the time of preparation, the subsequent receipt of information may result in material changes to the financial data and other information contained therein. The Debtors reserve the right to amend the Schedules and Statements from time to time as may be necessary or appropriate. These Global Notes Regarding Debtors' Schedules of Assets and Liabilities and Statements of Financial Affairs (the "Global Notes") are incorporated by reference in, and comprise an integral part of, the Schedules and Statements, and should be referred to and reviewed in connection with any review of the Schedules and Statements.

The Schedules and Statements and Global Notes should not be relied upon by any person for information relating to current or future financial conditions, events or performance of any of the Debtors. Due to numerous unliquidated, contingent and/or disputed claims, summary statistics in the Schedules, Statements and Global Notes likely understate the Debtors' liabilities.

1. <u>Reservation of Rights.</u> The Schedules and Statements are unaudited. Accordingly, although current management has made reasonable efforts to insure that the Schedules and Statements are accurate and complete based on information that was available to them at the time

of preparation, subsequent information or discovery may result in material changes to one or more of the Schedules and Statements; indeed inadvertent errors, omissions or inaccuracies may exist. Moreover, because the Schedules and Statements contain unaudited information, there can be no assurance that the Schedules and Statements are wholly accurate and complete. The Debtors reserve the right to amend and/or supplement any and all of the Schedules and Statements from time to time as they deem necessary and appropriate.

2. <u>Description of the Cases and "as of" Information Date</u>. On October 10, 2019, an involuntary petition was filed against Veterinary Care, Inc. On November 6, 2019, Veterinary Care, Inc. filed an answer consenting to relief, and the Court entered an order for relief on November 8, 2019. On November 18, 2019 (the "Petition Date"), TVET Management LLC filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. The cases are being jointly administered and no trustee or examiner has been appointed. The Debtors continues to operate its business as debtors-in-possession pursuant to Sections 1107(a) and 1108 of the Bankruptcy Code. The "as of" information in the Schedules and Statements for both Debtors is November 18, 2019.

The Chapter 11 Cases have been procedurally consolidated for the purpose of joint administration under case number 19-35736. Unless otherwise stated, asset and liability information is as of the Petition Date. Additionally, the Debtors have made every effort to allocate liabilities between the prepetition and post-petition periods based on the information and research that was conducted in connection with the preparation of the Schedules and Statements. As additional information becomes available to and further research is conducted by the Debtors, the Debtors' allocation of liabilities between pre-petition and post-petition periods may change.

- 3. <u>Basis of Presentation</u>. The Schedules and Statements do not purport to represent financial statements prepared in accordance with Generally Accepted Accounting Principles ("GAAP").
- 4. <u>Summary of Significant Reporting Policies</u>. The following conventions were adopted by the Debtors in the preparation of the Schedules and Statements
 - a. <u>Veterinary Care, Inc. and TVET Management, LLC</u>. Over the course of business operations, the Debtors acquired various veterinary practices, inheriting pre-existing assets and liabilities. As such, the assets and liabilities of the Debtors reside at various levels in the organization, including non-debtor operating entities. The assets and liabilities of both Debtors have been presented on a consolidated basis based on the information available at the time of preparation of the Schedules and Statements and best efforts were made to distinguish with which Debtor the asset or liability resides.
 - b. <u>Book Value</u>. Unless otherwise noted, each asset and liability of the Debtors is shown on the basis of the net book value of the asset or liability in accordance with the Debtors' accounting records as of the Petition Date. Unless otherwise noted, the Schedules reflect the carrying value of the assets and liabilities as listed in the Debtors' books and are not based upon any estimate of their current market values.
 - c. Currency. All amounts are reflected in U.S. Dollars.

- d. <u>Debtors' Consolidated Cash Management System</u>. The Debtors utilize a central and consolidated cash management system, which consists of multiple bank accounts. The Debtors manage the cash within the cash management system by transferring funds among bank accounts as needed based on cash receipts and disbursements.
- e. Payments Made within 90 Days Prior to the Petition Date. Payments made by the Debtors within 90 days prior to the Petition Date reflect all payments made to vendors or creditors within 90 days regardless of which Debtor or non-debtor was obligated to make payment.
- f. Transfers to Insiders within 1-year. Benjamin Thomas has been identified as an insider. Leah Thomas, Benjamin Thomas's spouse and former employee of Debtors, has also been included as an insider. Only Benjamin Thomas and Leah Thomas received payments or benefits greater than the \$6,825 threshold within one year. However, inclusion on or exclusion from the Schedules or Statements is not and shall not be construed as an admission or determination as to the legal status of any insider.
- g. Officers, Directors, Managing Members, General Partners, Members in Control, Controlling Shareholders. For preparation of the Schedules and Statements, all purported board members within one year, regardless of legal status, have been included. However, inclusion on the Schedules or Statements is not and shall not be construed as an admission or determination as to the legal status of any board member.
- h. Accounts Receivable. Due to the nature of the Debtors' business, payments are made to the Debtors in the form of cash, check card, or credit card. As such, a portion of Accounts Receivable is deposits in transit related to credit card processing. On a limited basis, the Debtors will extend customers credit, which typically represents less than 1% of revenue. Accounts Receivable listed on Schedule A is an aggregate amount of \$460,492, of which \$350,492 is deposits in transit related to credit card processing and the remaining \$110,000 is credit provided to customers. Accounts Receivable is stated as of October 31, 2019 but there is no material difference between October 31, 2019 and Petition Date.
- i. <u>Prepayments</u>. Prepayments include security deposits, prepaid rent, and prepaid insurance as of Petition Date. Prepayments are subject to impairment.
- j. <u>Inventory</u>. Inventory assets are purchased, sold, and consumed at the clinic level. The book value of inventory is recorded at the corporate level and therefore may differ from the individual clinic's inventory value, which may fluctuate during the normal course of business. Inventory count is performed quarterly, and fluctuations are recorded after each inventory count. Inventory listed on Schedule A is stated as of Petition Date.
- k. <u>Fixed Assets</u>. Certain owned fixed assets are purchased, operated and maintained at the clinic level. The book value of fixed assets listed on Schedule A are stated as

- of October 31, 2019, and there is no material difference between October 31, 2019 and Petition Date.
- 1. <u>Property and Equipment: Owned</u>. Property and equipment are capitalized and depreciated. Depreciation and amortization of other property and equipment are provided when assets are placed in service using the straight-line method based on estimated useful lives ranging from one to twenty years.
- m. <u>Property and Equipment: Leased.</u> In the ordinary course of their businesses, the Debtors lease real property and various articles of personal property from certain third-party lessors. All such leases are set forth in the Schedules. Leases not deemed to be capital leases are included on Schedule D and listed in the list of executory contracts contained in Schedule G.
 - Unpaid lease payments are listed in Schedule F (unsecured claims). However, nothing in the Schedules or Statements is or shall be construed as an admission or determination as to the legal status of any lease (including whether it is a true lease or a financing arrangement) and the Debtors reserve all rights with respect to all such issues.
- n. <u>Goodwill and other Intangible Assets</u>. Goodwill and other intangible assets listed on Schedule A is book value stated as of Petition Date. The book value of Goodwill and other Intangible Assets is subject to impairment.
- o. <u>Causes of Action</u>. The Debtors have not necessarily set forth all claims or causes of action against third parties as assets in the Schedules and Statements. The Debtors reserve all of their rights with respect to any such claims or causes of action they may have, and neither these Global Notes nor the Schedules and Statements shall be deemed a waiver of any such causes of action.
- p. <u>Seller Notes</u>. The Debtors financed acquisitions of veterinary hospitals by entering into financing arrangements with selling veterinary doctors ("Seller(s)") structured as either promissory notes ("Seller Note(s)") and/or convertible debentures ("Convertible Note(s)") paid by Debtors to Sellers. Certain Seller Notes and Convertible Notes contain security agreements that subordinate collateral of the Seller, including medical records and other assets, to Debtors' senior lender. Additionally, certain Sellers with Seller Notes and/or Convertible Notes lease real property to the Debtors. However, inclusion on or exclusion from Schedule D or Schedule F is not an admission or determination as to the legal status or security of any Seller Notes, Convertible Notes, or lease agreements and the Debtors reserve all rights with respect to all such issues.
- q. <u>Secured Claims</u>. Except as otherwise agreed pursuant to a stipulation or agreed order or order entered by the Bankruptcy Court, the Debtors reserve their rights to dispute or challenge the validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D of any Debtors. Moreover, although the Debtors may have

scheduled claims of various creditors as secured claims, except as otherwise agreed pursuant to a stipulation or agreed order or order entered by the Bankruptcy Court, the Debtors reserve all rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument (including without limitation, any intercompany agreement) related to such creditor's claim. Furthermore, secured claim amounts have been listed on Schedule D without regard to the value of assets secured thereby. No attempt was made by the Debtors to estimate the fair market value as of the Petition Date of assets pledged pursuant to a secured obligation. Accordingly, deficiency claims of secured creditors were not listed on Schedule F and such omission is not an admission by the Debtors as to the sufficiency of collateral related to any secured claim listed on Schedule D. In certain instances, Debtors may be a co-obligors, co-mortgagors or guarantors with respect to scheduled claims of other Debtors, and no claim set forth on Schedule D of the Debtors is intended to acknowledge claims of creditors that are otherwise satisfied or discharged by other entities. The descriptions provided in Schedule D are intended only to be a summary. Reference to the applicable loan agreements and related documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in the Global Notes or the Schedules and Statements shall be deemed a modification or interpretation of the terms of such agreements.

- r. Priority Claims. Priority claims related to various tax obligations have been listed on Schedule E. Moreover, although the Debtors may have scheduled claims of various creditors as priority claims, the Debtors reserve all rights to dispute or challenge the priority treatment of any such creditor's claim (or portion thereof) or the characterization of the structure of any such transaction or any document or instrument related to such creditor's claim. While reasonable efforts have been made, determination of the date upon which each claim in Schedule E was incurred or arose would be unduly burdensome and cost prohibitive, and therefore, the Debtors may not list a date for each claim listed on Schedule E.
- Executory Contracts. The business of the Debtors is complex. While every effort has been made to ensure the completeness and accuracy of the listing of executory contracts, inadvertent errors or omissions may have occurred. The Debtors hereby reserve all of their rights to dispute the validity, status, or enforceability of any contracts, agreements or leases set forth in Schedule G and to amend or supplement such Schedule as necessary. The contracts, agreements and leases listed on Schedule G may have expired, or been terminated, or may have been modified, amended, or supplemented from time to time by various amendments, restatements, waivers, estoppels certificates, letter and other documents, instruments and agreements which may not be listed therein. Certain of the real property leases listed on Schedule G may contain renewal options, guarantees of payments, options to purchase, rights of first refusal, rights to lease additional space and other miscellaneous rights. Such rights, powers, duties and obligations are not set forth on Schedule G. Certain of the executory agreements may not have been memorialized and could be subject to dispute. The presence of a contract or agreement on Schedule G does not constitute an admission that such contract or

agreement is an executory contract or unexpired lease. Similarly, the absence of a contract or agreement on Schedule G does not constitute an admission that any other contract or agreement to which the Debtors are a party is not executory. Parties to executory contracts and unexpired leases were not listed on Schedule F, except where past due amounts were recorded in the Debtors' accounts payable. The Debtors have not listed on Schedule F landlords and executory contract counter-parties which may have claims related to contract/lease rejection or other damages. The Debtors reserve all of their rights, claims and causes of action with respect to the contracts and agreements listed on the Schedules, including the right to dispute or challenge the characterization or the structure of any transaction, document, or instrument.

t. Other Long Term Liabilities and Other Current Liabilities. Certain Sellers participate in profit sharing arrangements as part of the Sellers' employment agreement with Debtors. The profit sharing agreements contain buyout clauses, which the Debtors carry on the balance sheet as a contingent liability in Other Long Term Liabilities. The liability is not due unless sellers exercise the buyout clause in their employment agreements. The profit sharing liability is approximately \$1.924 million as of Petition Date and is subject to change based on performance of the Seller's clinic(s). The profit sharing liability is not listed on the Schedules and Statements.

The remaining \$471,000 in Other Long Term Liabilities is a rebate paid upfront to Debtors from MWI. If Debtors fail to meet the minimum spend requirement, a prorata portion of the rebate is returned to MWI. This contingent liability is also not listed on the Schedules and Statements.

During the normal course of business, the Debtors accrue liabilities related to the timing of payroll and benefits. The value of these liabilities is represented by Other Current Liabilities on the Debtors' balance sheet. These liabilities have been paid to employees, and as such, Other Current Liabilities are not represented on the Schedules and Statements.

- 5. <u>Employee Claims</u>. Debtors have paid certain prepetition and post-petition employee wages, salaries, benefits and other obligations. Any Pre-Petition and Post-Petition obligations that have been paid since the Petition Date are not included on the Schedules and Statements.
- 6. <u>Disputed, Contingent and/or Unliquidated Claims</u>. Schedules D, E and F permit the Debtors to designate a claim as disputed, contingent and/or unliquidated. A failure to designate a claim on any of the Schedules as disputed, contingent and/or unliquidated does not constitute an admission that such claim is not subject to objection by the Debtors. The Debtors reserve the right to dispute, or assert offsets or defenses to, any claim reflected on the Schedules as to amount, liability or status.
- 7. <u>Global Notes Control</u>. In the event that the Schedules and Statements differ from the foregoing Global Notes, the Global Notes shall control.
