#### I. Summary

Assignment – On March 13, 2020, Wayzata Home Products, LLC, ("WHP") and its wholly-owned subsidiaries, cliqstudios.com LLC ("Cliqstudios"), 6 Square Cabinets LLC f/k/a Itasca Cabinets LLC, ("6 Square") and Wayzata Cabinetry LLC (hereinafter collectively the "Assignor"), executed and delivered to Lighthouse Management Group, Inc. (the "Assignee" or "Lighthouse") an assignment for the benefit of creditors ("Assignment"), which was filed with the Hennepin County District Court, on the same day, and comports with the requirements of Minn. Stat. § 577.13.

**Liquidation of Assignment Property** – All Assignment Property has been liquidated by the Assignee generating gross proceeds of \$3.4 million. Expenditures by the Assignee, as of the date of this Final Report, total less than \$1.9 million. After payment of final expenses, the Assignee estimates that approximately \$1.4 million will be available for distribution to the creditors.

**Creditor Claims** – The Assignee has identified 1,354 claimants, including customers, trade vendors, and employees holding 1,546 undisputed claims totaling \$38.4 Million. Of these, \$476,278 are priority claims and \$37,879,252 in non-priority, general unsecured claims.

**Motion to Distribute Proceeds and Discharge Assignee** – In conjunction with filing this Final Report, on December 23, 2020, the Assignee filed a motion seeking, among other things, approval to distribute to creditors the net proceeds collected by the Assignee and the discharge of the Assignee.

**Contents of this Final Report** – The purpose of this report (the "Final Report") submitted by the Assignee is to provide information required pursuant to Minn. Stat. § 576.38, subd. 3. Specifically, the law requires and this Final Report provides:

- 1. A description of the activities of the Assignee in the conduct of the Assignment;
- 2. A schedule of all Assignment Property at the commencement of the Assignment and any Assignment Property added thereafter;
- 3. A list of expenditures, including all payments to professionals retained by the Assignee;
- 4. A list of any unpaid expenses, if any, incurred during the Assignment;
- 5. A list of all dispositions of Assignment Property; and
- 6. A list of all distributions made or proposed to be made.

### II. Activities of the Assignee

Assignor's Business – Prior to the Assignment, the Assignor operated Cliqstudios, an online retail store which made, marketed, and sold kitchen cabinets. The Assignor employed approximately 300 employees with operations in four leased locations including a 70,000 sq. ft. headquarters in Edina, Minnesota ("Edina Location"), design centers in St. Louis, Missouri ("St. Louis Location"), and Indianapolis ("Indianapolis Location"), and a 1.8 million sq. ft. warehouse and manufacturing facility in Connersville, Indiana ("Connersville Location").

Assignor Ownership – Based on the Assignee's understanding, at one time, Andrew Juang and his brother, Samuel Juang, held a majority interest in Equus Holdings, Inc. ("Equus"). The Assignee also understands that, on August 4, 2007, Equus purchased all of the outstanding common stock from the Juang brothers and established an Employee Stock Ownership Plan. Today, Equus continues to be a 100% employee-owned corporation. It is also the Assignee's understanding that Andrew Juang owns a controlling ownership interests in Wayzata Holdings, LLC. Wayzata Holdings, LLC holds 67% of the Assignor's shares and Equus holds 1%. Cliq Holdings, Corp., a subsidiary of Great Hill, Partners L.P., holds 27% interest in the Assignor. The remaining 5% is held by management and other individuals.

Activities of the Assignee – On June 18, 2020, the Assignee filed an interim report describing the Assignees activities through that date. Those activities included the cessation of the Assignor's business operations, the exit from all leased facilities, the sale of Assignment Property, and the establishment of a claims process.

Since June, the Assignor's activities have focused on accounts receivable collections, the collection of \$153,739.39 held by Wells Fargo as collateral for an Irrevocable Letter of Credit and completing the claims process. The only anticipated tasks remaining to be completed by the Assignee are payment of final expenses and the distribution of the net proceeds collected to creditors.

### **III. Assignment Property**

**Assignment Property** – Assignment Property is defined in the Assignment as:

"all real property, fixtures, goods, stock, inventory, equipment, furniture, furnishings, accounts receivable, general intangibles, bank deposits, cash, promissory notes, cash value and proceeds of insurance policies, claims, and demands belonging to the assignor, wherever the property may be located."

**Assignment Property at the commencement of the Assignment** – The Assignee identified the following tangible and intangible assets held by the Assignor at the time the Assignee accepted the Assignment:

- Cash totaling \$951,469;
- Chargeback reserves totaling approximately \$1.7 million held by Wells Fargo;
- Approximately \$150,000 held by Well Fargo as collateral against an irrevocable letter of credit;
- Accounts Receivable totaling \$266,421;
- Prepayments and security deposits to insurance providers and other creditors;
- Inventory primarily located at the Connersville Location;
- Woodworking and finishing production at the Connersville Location;
- Intellectual Property (including trademarks, a digital footprint, website, other digital assets);
- Customer lists:
- IT infrastructure equipment; and
- Furniture and office equipment located at the Assignor's operating locations.

There was no Assignment Property added to the Assignment Estate after the Assignment was filed on March 13, 2020.

**Disposition of Assignment Property** – On April 28, 2020, the Court issued an order approving the sale of substantially all Assignment Property to CliqStudios Cabinets LLC ("CliqStudios Cabinets"), an Ohio limited liability company unaffiliated with the Assignor, for \$1.8 million. In a separate transaction, CliqStudios Cabinets purchased computer equipment located in the Edina Location for \$20,000. The remaining office equipment and furniture at the Edina Location was sold to Equus for \$50,000.

**Abandoned Assignment Property** –The Assignee abandoned certain Assignment Property after determining that the expense of obtaining control and selling these assets exceeded their value. Assignment Property that was abandoned includes:

- Backup infrastructure equipment located near Arnold, Maryland;
- Prepaid human resources assessments to evaluate and assess potential employees;

- Computer equipment and furniture located at the Indianapolis Location; and
- Computer equipment and furniture located at the St. Louis Location.

Although the Assignee abandoned the computer equipment at the Indianapolis and St. Louis Locations, costs were incurred to erase the data on the computers to ensure protection of any sensitive customer information.

The Assignee also abandoned approximately \$80,000 of accounts receivable, prepayments, and security deposits that were determined to be uncollectable.

### IV. Cash Receipts and Expenditures

Below in Table 1 is a Sources and Uses of Cash Statement identifying all cash receipts and disbursements by the Assignee through December 23, 2020. The total cash held by the Assignee as of December 23, 2020 is \$1,519,767.

Cash Receipts – Accounts receivable totaling \$182,580 have been collected. Cash receipts totaling \$1.9 million were received from the sale of Assignment Property. In addition, \$153,739.39 was received from Wells Fargo, who held this amount as collateral for an Irrevocable Letter of Credit.

**Cash Expenditures** – Cash expenditures by the Assignee total \$1.9 million. These expenditures include payroll and contract labor obligations totaling \$973,239, sales tax payments totaling \$269,250, shipping expenses of \$60,579, general and administrative expenses of \$86,842, and professional fees totaling \$517,329. Professional fees are summarized below in Table 2.

**Unpaid Expenses** – There are no unpaid expense, other than post-Assignment expenses due and owing to the Assignor's landlords for occupancy at the Edina Facility and Connersville Facility. Treatment of this debt is outlined in Section V below.

### V. Disposition of Assignment Property

**Creditor Claims** – The Assignor has identified 1,354 claimants, including customers, trade vendors, and employees holding 1,546 undisputed claims totaling \$38.4 million. Of these, \$476,278 are priority claims and \$37,879,252 in non-priority, general unsecured claims.

Claim Priority – On December 23, 2020, the Assignee filed a motion seeking approval to distribute all cash held by the Assignee, after payment of expenses, to creditors. Minnesota Statute Section 576.51 provides guidance to the Assignee on the priority of payment to creditors. The claimants in this Assignment who have priority to the unsecured claimants are those who: (1) hold administrative claims or "actual, necessary costs and expenses incurred during the [Assignment];" (2) have "claims for wages, salaries, or commissions, including vacation, severance, and sick leave pay, or contributions to an employee benefit plan, earned by the claimant within the 90 days before the time of appointment;" (3) have "unsecured claims of governmental units for taxes that accrued before the time of appointment." The remaining claims are "all other unsecured claims due as of the time of appointment." See Minn. Stat. § 576.51, subd. 1.

Class of Administrative Claimants – The first class of claimants hold administrative claims for "actual, necessary costs and expenses incurred during the [Assignment]" pursuant to Minn. Stat. § 576.51, subd. 1(2). There are only two claimants in this class. Both claimants are landlords of real property in which the Assignor occupied post-Assignment. Of the \$195,342.67 due to the two claimants, \$83,188.82 is due to the landlord for the occupancy of the Edina Facility through April 17, 2020; and \$112,153.85 is due for the occupancy of the Connersville Facility through April 3, 2020. The Assignee proposes that, based on Minnesota law, these claims be considered Minn. Stat. § 576.51, subd. 1(2) expenses and be paid in full in the final distribution to creditors. Attached and identified as Exhibit A is the Schedule of Administrative Claims.

Class of Employee 90-Day Claimants – The second class of claimants hold "claims for wages, salaries, or commissions, including vacation, severance, and sick leave pay, or contributions to an employee benefit plan, earned by the claimant within the 90 days before the time of appointment." Minn. Stat. § 576.51, subd. 1(3). This class is made up of those employees of the Assignor that hold employee benefits that were earned within 90 days of the date the Assignment was filed, March 13, 2020 – this includes commissions earned during this time period. While some employees will be paid in full based on their claim, other employees accrued benefits prior to the 90-day period, are not a part of this class and thus have an unsecured claim. Some of the Assignor's employees have a split claim and a portion will be paid in full (under Minn. Stat. § 576.51, subd. 1(3)), and the remaining amount will be considered an unsecured claim and be paid a on a pro-rata basis. Attached and identified as Exhibit B is the Schedule of Employee 90-Day Claims, and these claims will be paid in full.

Class of Tax Claimants – The third class of claimants hold "unsecured claims of governmental units for taxes that accrued before the time of appointment." Minn. Stat. § 576.51, subd. 1(6). Under Minnesota law, these claims have a priority over general unsecured claims, and will be paid in full. Attached and identified as Exhibit C is the Schedule of Tax Claims.

Class of Unsecured Claimants – The claims not identified above and in Exhibits A-C attached hereto are the remaining claims and are considered "all other unsecured claims due as of the time of appointment." *See* Minn. Stat. § 576.51, subd. 1(7). These claims will be paid on a pro-rata

basis at about 2.4% of the amount of the allowable claim. Attached and identified as Exhibit D is the Schedule of the Unsecured Claims.

The Assignee projects approximately \$1,400,000 will be available after final expenses to be distributed to the four classes of creditors. After paying creditors holding statutory-priority claims (one of the first three classes outlined above), approximately \$923,722 is projected to be available to pay the non-priority claims. Given that the pool of non-priority claimants totals \$37,879,252, they are projected to receive approximately 2.4% of their allowable claim.

Table 3 below provides a summary of the available Assignment proceeds and the projected distribution amount available to each of the four classes of claimants.

Claim Consolidation – Although the Assignor consists of several separate legal entities, the Assignee has determined that the actual operations were consolidated. All of the Assignor's employees worked for WHP and substantially all operating activities, vendor relations, IT infrastructure, and other primary business functions were operated as WHP. Cliqstudios and 6 Square were essentially marketing channels. While Cliqstudios was the Assignor's direct-to-consumer retail channel and the face of the business for most customers, 6 Square was the direct-to-contractor channel for sales to kitchen designers and other contractors. At the time the Assignment was filed, Wayzata Cabinetry was no longer in operation.

Due to the commingling of cash, assets, and opportunities, the Assignee is unable to match accurately cash receipts or creditor claims to specific Assignor entities. In its motion to approve a distribution to creditors, the Assignee consolidated all cash proceeds, regardless of source, and treated all creditor claims as being against a single entity.

VI. Discharge of Assignee

Motion to Discharge Assignee – In conjunction with filing this Final Report, on December 23,

2020, the Assignee filed a motion seeking the following:

1. Approval of distribution to creditors;

2. Approval to turnover any uncashed disbursements to charity;

3. Approval of the Assignee's interim and final reports;

4. Approval of the Assignee's fees and expenses;

5. Approval of the Assignee turning over any remaining assets or records to Wayzata Holdings, LLC; and

6. Discharge of the Assignee and termination of the ABC.

VII. Notice of Objection

**Notice of Objection Period** – Any objection to this Final Report must be filed with the Court and served on the Assignee. The objection must identify with specificity all items of the Final Report to which objection is made, the grounds for the objection, the facts supporting the objection and any legal authority. If there is no objection within 21 days of filing of this Final

Report, the Court may enter an order approving the Final Report and discharging the Assignee

without the necessity of a hearing. Minn. Stat.  $\S$  576.38, subd. 4.


