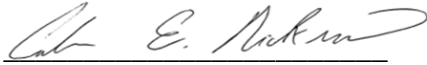

NOTICE OF CLAIM

THIS NOTICE OF CLAIM is being provided to you because you are a possible creditor of Assignor, Wayzata Home Products, LLC and its subsidiaries, including cliqstudios.com LLC, 6 Square Cabinets LLC f/k/a Itasca Cabinets LLC, and Wayzata Cabinetry LLC (collectively “Assignor”).

THE VALUE OF YOUR CLAIM: On March 13, 2020, the Assignor assigned its assets to Lighthouse Management Group, Inc., (“Assignee”) pursuant to Minnesota Statute Chapter 577.11. The Assignee is responsible for liquidating all of the Assignor’s assets and distributing the remaining proceeds to the Assignor’s creditors. The Assignee estimates that approximately \$1 million-\$1.5 million may be available to pay creditor claims totaling approximately \$48 million. These estimates could change significantly as more information is obtained. Any distribution to creditors will be made on a pro-rata basis in their respective orders of priority as defined in Minnesota Statute Chapter 576.49. Under this likely scenario, most creditors’ claims will be paid based on a pro-rata distribution at 2%-4% of the amount owed to the claimant.

The Assignee has reviewed all of the available records to determine the amounts the Assignor may owe you (“Claim Amount”). Your Claim Amount is identified on line 4 of the attached Proof of Claim form.

If you agree with the information on line 4 of the attached Proof of Claim form, there is nothing more for you to do. If, however, you disagree with the Claim Amount, you must complete and submit the Proof of Claim form to the Assignee. The Proof of Claim form must be completed by you, sent via U.S. Mail (or by email at Cliqclaim@lighthousemanagement.com) and received by the Assignee no later than 5:00 p.m. CDT on July 29, 2020.
