ORDER ON REQUESTS FOR EMERGENCY TREATMENT

The requests of the debtors in these jointly administered cases for emergency treatment as to the below-listed motions is hereby granted as follows:

1. The Court will hold a hearing on Tuesday, March 27, 2018, at 1:00 p.m. on the following motions:
 - a. [#6] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Establish Case Management Procedures;
 - b. [#8] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Approve Order (I) Authorizing the Debtors to Prepare (A) a Consolidated List of Creditors and (B) a Consolidated List of the Debtors Thirty Largest Unsecured Creditors, (II) Authorizing Certain Procedures to Maintain the Confidentiality of Patient Information as Required by Privacy Rules, and (III) Approving the Form and Manner of the Notice of Commencement;
 - c. [#9] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Approve Order Pursuant to 28 U.S.C. § 156(c) (I) Approving Retention and Appointment of Donlin, Recano & Company, Inc. as Claims and Noticing Agent to Debtors, Effective Nunc Pro Tunc to Petition Date and (II) Granting Related Relief;
 - d. [#12] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Approve Order (A) Authorizing Debtors to (I) Pay Certain Employee Compensation and Benefits and (II) Maintain and Continue Such Benefits and Other Employee Related Programs and


(B) Authorizing and Directing Banks and Financial Institutions to Honor and Process Checks and Transfers Related to Such Obligations;

- e. [#13] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Approve Order (I) Authorizing Debtors to (A) Continue Their Workers Compensation Program and Insurance Programs, (B) Pay All Obligations In Respect Thereof, (C) Continue to Honor Premium Financing Obligations, and (II) Authorizing and Directing Banks and Financial Institutions to Honor and Process Checks and Transfers Related to Such Obligations;
- f. [#15] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Approve Order (I) Approving Debtors Proposed Form of Adequate Assurance of Payment to Utility Companies, (II) Establishing Procedures for Resolving Objections By Utility Companies And (III) Prohibiting Utility Companies From Altering, Refusing, or Discontinuing Service;
- g. [#16] Emergency Motion filed by Debtors Wachusett Ventures, LLC et al. to Pay Taxes and Fees; and
- h. The Debtors shall immediately serve the Motions and give notice of this order to the United States Trustee, all secured creditors, the taxing authorities, the Attorney General of the Commonwealth of Massachusetts, the United States Attorney for the District of Massachusetts, the thirty largest unsecured creditors, the taxing authorities, and affected utilities, and shall file a certificate of such service and notice.
