**ORDER SCHEDULING HEARING**

Before the Court for consideration is Debtor's Motion for Emergency Hearing (ECF No. 21) requesting that the Court schedule a hearing to consider the following motions (collectively, the "First Day Motions"):

1. Debtor's Motion for Interim and Final Orders (A) Authorizing Debtor's Use of Cash Collateral and (B) Granting Replacement Liens (ECF No. 11);
2. Debtor's Motion for Entry of Interim and Final Orders (I) Authorizing the Debtor to (A) Continue Existing Cash Management System, (B) Maintain Existing Bank Accounts, (C) Maintain Existing Business Forms; (II) Scheduling Final Hearing; and (III) Granting Related Relief (ECF No. 14);
3. Debtor's Motion for Interim and Final Orders (I) Prohibiting Utility Companies from Altering, Refusing, or Discontinuing Services to, or Discriminating Against, the Debtor on Account of Prepetition Amounts Due; (II) Deeming Utility Providers Adequately Assured of Future Performance; (III) Establishing Procedures for Requests for Additional Adequate Assurance of Payment; and (IV) Granting Certain Related Relief (ECF No. 9); and
4. Debtor's Motion for Entry of Order Authorizing the Debtor to Honor Certain

Prepetition Obligations to Customers, and to Continue Certain Customer Programs.  
(ECF No. 10).

For good and sufficient cause shown, it is hereby ORDERED, that the Debtor's Motion for Emergency Hearing is GRANTED. This Court will conduct a hearing on the Debtor's First Day Motions at the **C.F. Haynsworth Federal Building and U.S. Courthouse, 300 East Washington Street, Greenville, SC 29601, on December 12, 2022, at 9:30 a.m.** It is further ORDERED, that counsel for the Debtor shall serve a copy of this Order Scheduling Hearing and the First Day Motions on (i) the Office of the United States Trustee for the District of South Carolina; (ii) the Office of the United States Attorney General for the District of South Carolina; (iii) the Internal Revenue Service; (iv) Auto Money, Inc.; (v) all utility providers; (vi) the holders of the twenty (20) largest unsecured claims against the Debtor; (vii) all parties who, as of the filing of this motion, have filed a notice of appearance and request for services of papers pursuant to Bankruptcy Rule 2002; and (viii) James R. Faucher, by hand delivery, facsimile, electronic mail or overnight delivery **by 5 p.m. December 5, 2022.** Thereafter, counsel shall file a certificate of service with this Court. Any responses to the First Day Motions must be filed with the Court and served on Debtor's counsel on or before **Friday, December 9, 2022, at 2:00 p.m.**
