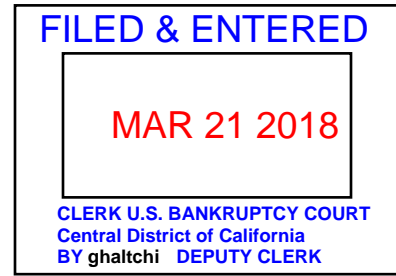

1 The Court having considered the *Stipulation Between the Debtor, Siena Lending Group,*
2 *LLC and the Official Committee of Unsecured Creditors Continuing the Final Hearing on the*
3 *Debtor's Motion to Approve Financing Stipulation* [Docket No. 83] (the "Stipulation") entered
4 into by and among the Debtor and Debtor-in-Possession B&B Liquidating, LLC, f/k/a B&B
5 Bachrach, LLC, (the "Debtor"), Siena Lending Group, LLC ("Siena") and the Official Committee
6 of Unsecured Creditors (the "Committee") (collectively, the "Parties"), through their counsel of
7 record, pursuant to which the Parties have requested a continuance of the Court's final hearing
8 scheduled for March 20, 2018 at 2:00 p.m. (the "Final Hearing") on the Debtor's *Emergency*
9 *Motion for Interim and Final Orders Approving Stipulation with Siena Lending Group LLC; (1)*
10 *Authorizing Post-Petition Financing; (2) Authorizing Debtor's Use of Cash Collateral; and (3)*
11 *Related Relief* [Docket No. 21] (the "Financing Motion"), and good cause appearing therefor,

12 IT IS ORDERED:

- 13 1. The Stipulation is approved and the terms of the Stipulation are incorporated as
14 though set forth herein.
- 15 2. The hearing on the Financing Motion scheduled for March 20, 2018 at 2:00 p.m. is
16 continued to April 5, 2018 at 2:00 p.m. in the above captioned courtroom (the "Continued Final
17 Hearing"), without prejudice to the right of the Parties to seek further continuance of the
18 Continued Final Hearing by stipulation.
- 19 3. The debtor is directed to serve a copy of this order on all persons who are entitled
20 to notice of the continued hearing.
