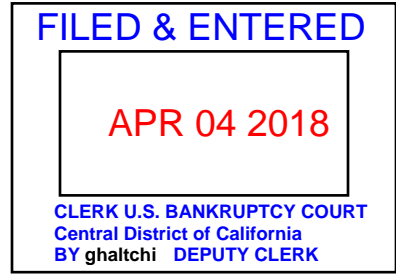

1 The Court having considered the *Second Stipulation Between the Debtor, Siena Lending*  
2 *Group, LLC and the Official Committee of Unsecured Creditors Continuing the Final Hearing on*  
3 *the Debtor's Motion to Approve Financing Stipulation and Submission of Extended Budget*  
4 [Docket No. 108] (the "Stipulation")<sup>1</sup> entered into by and among the Debtor and Debtor-in-  
5 Possession B&B Liquidating, LLC, f/k/a B&B Bachrach, LLC, (the "Debtor"), Siena Lending  
6 Group, LLC ("Siena") and the Official Committee of Unsecured Creditors (the "Committee")  
7 (collectively, the "Parties"), through their counsels of record, pursuant to which the Parties have  
8 requested a further continuance of the Court's final hearing currently scheduled for April 5, 2018  
9 at 2:00 p.m. (the "Final Hearing") on the Debtor's *Emergency Motion for Interim and Final*  
10 *Orders Approving Stipulation with Siena Lending Group LLC; (1) Authorizing Post-Petition*  
11 *Financing; (2) Authorizing Debtor's Use of Cash Collateral; and (3) Related Relief* [Docket No.  
12 21] (the "Financing Motion"), and good cause appearing therefor,

13 IT IS ORDERED:

- 14 1. The Stipulation is approved and the terms of the Stipulation are incorporated as  
15 though set forth herein.
- 16 2. The hearing on the Financing Motion scheduled for April 5, 2018 at 2 :00 p.m. is  
17 continued to May 1, 2018 at 2:00 p.m. in the above captioned courtroom (the "Continued Final  
18 Hearing"), without prejudice to the right of the Parties to seek further continuance of the  
19 Continued Final Hearing by stipulation.
- 20 3. Notwithstanding anything in the Financing Stipulation, the Financing Motion, or  
21 the Interim Order to the contrary, the deadline for the Committee to challenge Siena's lien, claim,  
22 security interest or causes of action covered by the Debtor's stipulations is extended to 30 days  
23 after the Continued Final Hearing and may be further extended by agreement of the Parties or  
24 Court order.
- 25 4. Subject to the Final Hearing or the filing of any superseding budget, the extended  
26 Budget attached as Exhibit A to the Stipulation shall be applicable to the Financing Stipulation

1 and Financing Motion and supersedes all prior Budget's submitted to the Court.

2 5. The debtor is directed to serve a copy of this order on all persons who are entitled  
3 to notice of the continued hearing.
