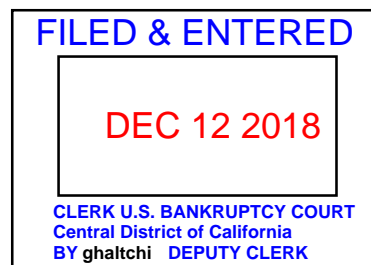

8 in fees and \$2,058.69 in expenses, for an aggregate of \$122,138.69.


9 2. The Debtor is authorized to pay PSZ&J the aforementioned amounts, less any
