PLEASE TAKE FURTHER NOTICE that, on March 29, 2017, the Debtors filed the *Notice of Rescheduled Omnibus Hearings* [Docket No. 255] (the “Rescheduling Notice”), which provides that the omnibus hearing previously scheduled on April 20, 2017 at 2:00 p.m. (Eastern Time) was adjourned to April 27, 2017 at 2:00 p.m. (Eastern Time).

PLEASE TAKE FURTHER NOTICE that, in accordance with the Rescheduling Notice, the hearing on the Application will be held before the Honorable Shelley C. Chapman at the United States Bankruptcy Court for the Southern District of New York, One Bowling Green, New York, NY 10004 (the “Bankruptcy Court”) on **April 27, 2017 at 2:00 p.m. (Eastern Time)** (the “Hearing”).

PLEASE TAKE FURTHER NOTICE that any responses or objections (“Objections”) to the Application shall be in writing, shall conform to the Federal Rules of Bankruptcy Procedure and the Local Bankruptcy Rules for the Southern District of New York, shall be filed with the Bankruptcy Court (a) by attorneys practicing in the Bankruptcy Court, including attorneys admitted pro hac vice, electronically in accordance with General Order M-399 (which can be found at www.nysb.uscourts.gov), and (b) by all other parties in interest, on a CD-ROM, in text-searchable portable document format (PDF) (with a hard copy delivered directly to Chambers), in accordance with the customary practices of the Bankruptcy Court and General Order M-399, to the extent applicable, and shall be served in accordance with General Order M-399 and the *Order (I) Establishing Certain Notice, Case Management, and*

Administrative Procedures and (II) Granting Related Relief, dated March 7, 2017 [Docket No. 90], so as to be so filed and received no later than **April 20, 2017 at 4:00 p.m. (Eastern Time)** (the “Objection Deadline”).

PLEASE TAKE FURTHER NOTICE that that if an Objection to the Application is not received by the Objection Deadline, the relief requested shall be deemed unopposed, and the Bankruptcy Court may enter an order granting the relief sought without a hearing.
