**NOTICE OF PRESENTMENT OF STIPULATION AND AGREED  
ORDER RESOLVING PLAN ADMINISTRATOR’S FOURTEENTH  
OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CERTAIN CLAIMS  
(DUPLICATE, LATE FILED, NO LIABILITY AND RECLASSIFIED) AS  
IT RELATES TO CITY OF MONROE TAX CLAIM NO. 487**

**PLEASE TAKE NOTICE** that on November 2, 2018, David MacGreevey, in his capacity as plan administrator (the “Plan Administrator”), filed the annexed *Stipulation and Agreed Order Resolving the Plan Administrator’s Fourteenth Omnibus (Non-Substantive) Objection to Certain Claims (Duplicate, Late filed, No Liability and Reclassified) as it Relates to City of Monroe Tax Claim No. 487* [Docket No. 1026] (the “Stipulated Order”).<sup>2</sup>

**PLEASE TAKE NOTICE** that the parties to the Stipulated Order hereby provide notice of presentment of the Stipulated Order, which is annexed hereto, as set forth below.

**PLEASE TAKE FURTHER NOTICE THAT the Plan Administrator, by and through undersigned counsel, will present the annexed Stipulated Order, agreed to between the Plan Administrator and City of Monroe Tax, to the Honorable Shelley C. Chapman, United States Bankruptcy Judge, at the United States Bankruptcy Court of the Southern District of New York, Alexander Hamilton Custom House, One Bowling Green, New York, New York 10004, on November 12, 2018 at 12:00 pm (prevailing Eastern Time).**

**PLEASE TAKE FURTHER NOTICE** that any responses or objections (each, an “Objection”) to the Stipulated Order shall be in writing, shall conform to the Federal Rules of Bankruptcy Procedure, the Local Bankruptcy Rules for the Southern District of New York, and the *Order (I) Establishing Certain Notice, Case Management, and Administrative Procedures and (II) Granting Related Relief* [Docket No. 90] (the “Case Management Order”), shall set forth the basis for the Objection and the specific grounds therefor, and shall be filed with the Court electronically in accordance with General Order M-399 by registered users of the Court’s case filing system (the User’s Manual for the Electronic Case Filing System can be found at <http://www.nysb.uscourts.gov>, the official website for the Court), with a hard copy delivered directly to chambers pursuant to Local Rule 9070-1 and served so as to be actually received no later than **November 9, 2018 at 4:00 p.m. (prevailing Eastern Time)** (the “Objection Deadline”).

**PLEASE TAKE FURTHER NOTICE** that if an Objection is not filed and served by the Objection Deadline in accordance with the preceding paragraph, there will not be a hearing and the Stipulated Order may be signed.

**PLEASE TAKE FURTHER NOTICE** that if an Objection is timely filed and served, the Court will notify the moving and objecting parties of the date and time of the hearing and of the moving party's obligation to notify all other parties entitled to receive notice. The moving and objecting parties are required to attend the hearing, and failure to attend in person or by counsel may result in relief being granted or denied upon default.

**STIPULATION AND AGREED ORDER RESOLVING PLAN  
ADMINISTRATOR’S FOURTEENTH OMNIBUS (NON-SUBSTANTIVE)  
OBJECTION TO CERTAIN CLAIMS (DUPLICATE, LATE FILED, NO LIABILITY  
AND RECLASSIFIED) AS IT RELATES TO CITY OF MONROE TAX CLAIM NO. 487**

This stipulation (the “Stipulation”) is made between David MacGreevey, in his capacity as plan administrator (the “Plan Administrator”) acting on behalf of Runway Liquidation Holdings, LLC, and its affiliated post-effective date debtors (collectively, the “Post-Effective Date Debtors” and before the Effective Date of the Plan, the “Debtors”), and the City of Monroe Tax (“City,” and together with the Plan Administrator, collectively, the “Parties”), by and through the undersigned counsel. The City of Monroe is an incorporated municipality located in Butler County, Ohio.

Pursuant to state law and municipal ordinance, the City of Monroe levies a withholding tax upon the income of all employees working within the city limits. By law, employers are required to withhold and remit this tax to the City. The City also levies a tax on the net profit earned by companies operating within the city limits.

The Debtors operated a retail location at the Cincinnati Premium Outlets, located within the City of Monroe. The Debtors did not file all required withholding tax returns and did not file any net profit returns.

### **RECITALS**

**WHEREAS**, on February 28, 2017 (the “Petition Date”), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code.

**WHEREAS**, on July 26, 2017, the Court entered its *Findings of Fact, Conclusions of Law, and Order Confirming the Amended Joint Plan of Reorganization of BCBG Max Azria Global Holdings, LLC and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 591] confirming the chapter 11 plan annexed thereto (the “Plan”).

**WHEREAS**, on July 31, 2017, the Effective Date of the Plan occurred. *See Notice of (I) Entry of Order Confirming the Amended Joint Plan of Reorganization of BCBG Max Azria Global Holdings, LLC and its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code and (II) Occurrence of Effective Date* [Docket No. 601]. Pursuant to the Plan, the Plan Administrator was appointed on the Effective Date “to implement the Plan and to make distributions thereunder and wind down the businesses and affairs of the Debtors and Post-Effective Date Debtors.” Plan at Article IV.E. This includes the authority “to File, withdraw, or litigate to judgment objections to Claims or Interests.” *Id.* at Article VII.B.

**WHEREAS**, on September 28, 2017, the Court entered the Objection Procedures Order.

**WHEREAS**, on May 15, 2017, the City filed a proof of claim identified as claim number 487 on the Claims Register (“Claim 487”) asserting a priority claim in the amount of \$8,975.56, on account of taxes due.

**WHEREAS**, on May 12, 2018, the City filed an amended proof of claim identified as claim number 1195 on the Claims Register (“Claim 1195”) asserting a priority claim in the amount of \$8,975.56, on account of taxes due.

**WHEREAS**, on April 23, 2018, the Plan Administrator filed the *Plan Administrator’s Fourteenth Omnibus (Non-Substantive) Objection to Certain Claims (Duplicate, Late filed, No Liability and Reclassified)* [Docket No. 878] (the “Objection”). The Plan Administrator objected to Claim 487 seeking to disallow and expunge Claim 487 on the basis that the Debtors’ books and records do not show any liability to the City.

**WHEREAS**, the Plan Administrator and the City have agreed to resolve the Objection and otherwise resolve all disputes regarding Claim 487 on the terms and conditions set forth in this Stipulation.

### **STIPULATION**

**NOW, THEREFORE**, in consideration of the foregoing, the Parties hereby agree and stipulate as follows:

1. The foregoing recitals are hereby fully incorporated into and made an express part of this Stipulation.
2. This Stipulation is made expressly contingent upon approval of, and entry by, the Bankruptcy Court (the date of such entry being referred to herein as the “Stipulation Effective Date”) and, should the Stipulation not be approved and entered, the Parties will be deemed to have returned to their respective positions immediately prior to the execution of this Stipulation with all rights and privileges reserved.
3. The parties agree that Claim 487 shall be disallowed in its entirety.

4. The Parties agree that Claim 1195 shall be allowed as a general unsecured claim in the amount of \$20,000 (the “GUC Amount”).

5. The City agrees to waive its right to assess the unpaid taxes against the responsible parties.

6. The GUC Amount shall be paid in accordance with the Plan.

7. This Stipulation shall be binding upon, and shall inure to the benefit of each of, the Plan Administrator, the Post-Effective Date Debtors, the City, and each of their respective agents, employees, representatives, assigns, successors in interest, and attorneys, and shall be binding and effective.

8. The City represents that it has not transferred any claim (or any portion thereof) that is the subject of this Stipulation.

9. Each of the Parties shall be responsible for its respective costs and expenses (including, without limitation, attorneys’ fees and expenses) incurred by it in negotiating, drafting, and executing this Stipulation and shall not be responsible for the payment of any such fees or expenses incurred by any other party hereto.

10. This Stipulation constitutes the entire agreement between the Parties and may not be amended or modified in any manner except by a writing signed by both of the Parties or their counsel and approved by the Bankruptcy Court.

11. This Stipulation shall be governed by and construed in accordance with the laws of the State of New York without regard to any law concerning the conflicts of laws.

12. Each Party and signatory to this Stipulation represents and warrants to each other Party that such Party or signatory has full power, authority, and legal right and has obtained all approvals and consents necessary to execute, deliver, and perform all actions required under this

Stipulation and, where applicable, has obtained all authority, approvals, and consents necessary to act on behalf of another Party to execute, deliver, and perform all actions required under this Stipulation.

13. The Bankruptcy Court shall retain exclusive jurisdiction to hear and finally determine all disputes arising from or related to this Stipulation, including the performance of the Parties' obligations hereunder and the interpretation of this Stipulation. The Parties each consent to the Bankruptcy Court hearing and finally determining all such disputes. Further, the Parties each agree to waive trial by jury in an action, proceeding, or counterclaim brought by or on behalf of the Parties hereto with respect to any such dispute.
