**NOTICE OF HEARING**

**PLEASE TAKE NOTICE THAT** on August 15, 2018, The Official Committee of Asbestos Claimants (the "Committee"), filed *Motion of The Official Committee of Asbestos Claimants to (I) Dismiss the Debtor's Chapter 11 Case for Cause as a Bad Faith Filing Pursuant to 11 U.S.C. § 1112(b), or Alternatively, (II) Transfer Venue in the Interest of Justice and for the Convenience of the Parties Pursuant to 28 U.S.C. § 1412 (The "Motion")*.

**PLEASE TAKE FURTHER NOTICE THAT** your rights may be affected. You should read the Motion carefully and discuss the Motion with your attorney. If you do not have an attorney, you may wish to consult one.

**IF YOU DO NOT WANT THE COURT TO GRANT THE RELIEF REQUESTED IN THE MOTION, OR IF YOU WANT THE COURT TO CONSIDER YOUR VIEWS ON THE MOTION, THEN YOU MUST:**

1. A. On or before August 29, 2018 (the "Response Deadline"), file a written response with the Bankruptcy Court at:

If you have your attorney file a written response, then the response should be filed with the United States Bankruptcy Court for the Western District of North Carolina (the "Bankruptcy Court") by electronic means through the Bankruptcy Court's website, [www.ncwb.uscourts.gov](http://www.ncwb.uscourts.gov), under the Debtor's name and case number, as listed above, by the Response Deadline.

2. Serve a copy of such response, on or before the Response Deadline, on (A) the undersigned counsel for the Committee, (B) all of the parties required to be served pursuant to the Notice, Case Management and Administrative Procedures approved

by the Bankruptcy Court in its Order Establishing Certain Notice, Case Management and Administrative Procedures (Docket No. 65) (the "Case Management Order") and (C) any other parties required to be served by law or other orders of the Court.

3. Attend the hearing (the "Hearing") scheduled for **Thursday, September 20, 2018**, at **9:30 a.m.** (prevailing Eastern Time), or as soon thereafter as can be heard, before the Honorable Judge Laura T. Beyer at the United States Bankruptcy Court for the Western District of North Carolina, Charlotte Division, Courtroom 1-5, 401 West Trade Street, Charlotte, North Carolina 28202.

**PLEASE TAKE FURTHER NOTICE THAT** if you or your attorney do not take these steps, the Bankruptcy Court may decide that you do not oppose the relief sought and may enter an order granting the relief requested in the Motion.

**PLEASE TAKE FURTHER NOTICE THAT** you need not appear at the Hearing if you do not object to the relief requested in the Motion.

**PLEASE TAKE FURTHER NOTICE THAT** the Hearing may be continued or adjourned from time to time without further notice other than an announcement of the adjourned date or dates at the Hearing or at a later hearing.

**PLEASE TAKE FURTHER NOTICE THAT** if you would like to receive copies of the Motion or the Case Management Order, you may access such documents: (A) for a nominal fee at the website of the Bankruptcy Court, [www.ncwb.uscourts.gov](http://www.ncwb.uscourts.gov), under the Debtor's name and case number, as listed above; (B) free of charge at the website of the Debtor's claims and noticing agent, Donlin, Recano & Company, Inc., at [www.donlinrecano.com/bestwall](http://www.donlinrecano.com/bestwall); or (C) by written request directed to the undersigned counsel.
