**SUPPLEMENTAL DECLARATION OF VINEET (“VIN”) BATRA IN  
FURTHER SUPPORT OF DEBTORS’ APPLICATION TO EMPLOY AND  
RETAIN DUFF & PHELPS SECURITIES, LLC AS INVESTMENT BANKER  
TO THE DEBTORS AND DEBTORS IN POSSESSION  
NUNC PRO TUNC TO THE PETITION DATE**

1. I am a Senior Advisor to Duff & Phelps Securities, LLC (“**Duff & Phelps**”), a financial advisory and investment banking firm which has its principal office at 55 East 52nd Street, 31st Floor, New York, New York 10055. I am submitting this Declaration (this “**Supplemental Declaration**”) in support of the Debtors’ application (the “**Application**”) for entry of an order authorizing and approving the employment and retention of Duff & Phelps as their investment banker, on the terms set forth in the Duff & Phelps Agreement. I am authorized to make this Supplemental Declaration on behalf of Duff & Phelps. Except as otherwise noted,<sup>2</sup> I have personal knowledge of the matters set forth herein. Unless otherwise defined, capitalized terms used but not defined herein shall have the meanings ascribed to them in the Application.

2. On December 4, 2018, the Debtors filed the *Debtors’ Application to Employ and Retain Duff & Phelps Securities, LLC as Investment Banker to the Debtors and Debtors in Possession Nunc Pro Tunc to the Petition Date* [Docket No. 128] (the “**Application**”). Along

with the filing of the Application, the Debtors filed the Declaration of Vineet (“Vin”) Batra in Support of the Application (the “**Original Declaration**”).

3. As of December 31, 2018, Duff & Phelps Managing Director Brian Cullen now leads the firm’s engagement for the Debtors, and my role with Duff & Phelps has changed from Managing Director to Senior Advisor. As a Senior Advisor, I will serve as an independent contractor working at Duff & Phelps’ direction and will perform the same services for the Debtors as I had been providing prior to my change in status. For this reason regardless of the additional personnel provided to the Debtors pursuant to this new arrangement, Duff & Phelps’ services to the Debtors will not change. Moreover, the total fees to be charged to the Debtors pursuant to the Duff & Phelps Agreement will remain unchanged.

4. Accordingly, in connection with the Application and the Original Declaration, I submit this Supplemental Declaration to provide additional disclosures in accordance with Bankruptcy Rule 2014(a).

5. Duff & Phelps has performed a supplemental conflict check with respect to an expanded list of creditors and equity holders and other interested parties provided to Duff & Phelps by the Debtors, which list is attached hereto as Schedule 1 (the “**Interested Parties List**”). To the best of my knowledge, information and belief, the only entities on the Interested Parties List with whom Duff & Phelps has any connection whatsoever are the entities identified on the Interested Parties List. The services provided to Duff & Phelps by such entities on the Interested Parties List are completely unrelated to the services to be provided by Duff & Phelps to the Debtors in these cases.

6. In connection with the Interested Parties List, the office of the United States Trustee has requested additional disclosures regarding Duff & Phelps’ work for affiliates of

Atalaya Administrative (“**Atalaya**”) and Milestone Partners (“**Milestone**”). Duff & Phelps reviewed its records regarding work with Atalaya and Milestone since the commencement of 2017. During the past year, Duff & Phelps worked for Atalaya on two projects, including (i) conducting a valuation of a portfolio of 29 investments and (ii) providing assistance with financial due diligence on a potential acquisition target, both of which Duff & Phelps completed in September 2018. In addition, Duff & Phelps expects additional projects from Atalaya during 2019. Regarding Milestone, Duff & Phelps was engaged in 2018 to perform financial and tax due diligence in connection with an acquisition, which project was completed in June of 2018. None of the engagements described in this paragraph relate to the Debtors in any way, and none of the professionals who performed the services described in this paragraph are involved in the current restructuring engagement for the Debtors. Additionally, none of these connections account for more than 2% of Duff & Phelps’ annual revenue over the past two years.

7. Except as otherwise set forth herein, to the best of my knowledge, information and belief, and based on the foregoing, (i) Duff & Phelps does not hold or represent any interest adverse to the Debtors, their creditors or other parties in interest, as identified to Duff & Phelps on the Interested Parties List, with respect to the matters upon which Duff & Phelps is to be engaged and (ii) Duff & Phelps is not connected with the Debtors, their creditors or other parties in interest on the Interested Parties List. Accordingly, I respectfully submit that Duff & Phelps is a “disinterested person,” as defined in section 101(14) of the Bankruptcy Code.

8. It should be understood that Duff & Phelps’ present and former clients and such clients’ affiliates, officers, directors, principal shareholders and their respective affiliates may have had relationships with the foregoing entities of which Duff & Phelps was not informed or may have developed relationships of which Duff & Phelps is unaware. Despite the efforts

described above to identify and disclose Duff & Phelps' connections with parties in interest in these cases, because the Debtors constitute a large enterprise with numerous unidentified creditors and other relationships, Duff & Phelps is unable to state with certainty that every client representation or other connection has been disclosed. In this regard, if Duff & Phelps discovers additional information that requires disclosure, Duff & Phelps will file a supplemental disclosure with the Court as promptly as possible.

9. Subsequent to the filing of the Application, Duff & Phelps has agreed not to charge the Debtors on an hourly basis for court testimony unless Duff & Phelps' retention is expanded pursuant to further Court order. To the extent it becomes relevant, standard hourly rates for Duff & Phelps' professionals are as follows:

10. I further state that, to the best of my knowledge, information and belief, the proposed engagement of Duff & Phelps is not prohibited by Bankruptcy Rule 5002.
