CHAPTER 11 FILING AND RELATED MATTERS

The undersigned, constituting all of the members of the Management Committee (the “**Committee**”) of FOODSERVICEWAREHOUSE.COM, LLC, a Delaware limited liability company (the “**Company**”), in accordance with the authority contained in the Delaware Limited Liability Company Act and the Operating Agreement of the Company, hereby consents to the adoption of the following resolutions:

NOW, THEREFORE, BE IT RESOLVED, THAT:

1. If Thomas Kim and Richard Nevins (the “IC Members”), the members of the independent committee of the Committee (the “IC”), determine it is advisable and in the best interests of the Company that the Company file a voluntary petition for relief under Chapter 11 of Title 11 of the United States Code (the “Bankruptcy Code”), in which the authority to operate as debtor-in-possession will be sought, the filing of such bankruptcy petition commencing a chapter 11 bankruptcy case (“Chapter 11 Case”) be, and it hereby is, authorized in all respects.
2. The IC Members in their capacity as members of the IC shall have the exclusive authority to exercise any and all authority granted to the Committee in the Operating Agreement of the Company, or applicable law, with respect to the Restructuring (as such term is defined in the “Act by Written Consent of Management Committee of Foodservicewarehouse, LLC - Appointment of CEO, Election of Members, Creation of Independent Committee, and Related Matters” dated March 16, 2016 (the “Prior Consent”)) and nothing contained in this Consent shall diminish or restrict the authority of the IC under the Prior Consent which remains in full force and effect.
3. The IC Members be and are hereby appointed as the authorized signatories of the Company in connection with a Chapter 11 Case of the Company authorized herein.
4. The IC Members are hereby authorized, empowered, and directed for, on behalf of, and in the name of, the Company to execute, deliver, verify and/or certify petitions under Chapter 11 of the Bankruptcy Code and to cause the same to be filed in any United States Bankruptcy at such time as the IC Members executing the same shall determine.
5. The IC Members are hereby authorized, empowered and directed for, on behalf of, and in the name of, the Company to execute and file, in connection with a Chapter 11 Case, the following nonexclusive things, all petitions, schedules, lists, pleadings,

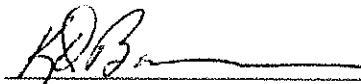
applications, motions, complaints, affidavits, certificates, instruments, documents, agreements, requests, directions, receipts, other papers, plans of reorganization, disclosure statements, or the like, and any amendments, supplements, or modifications of the above, and fully perform or caused to be performed the terms and provisions thereof, and to take any and all actions that the IC Members may deem necessary, proper, appropriate, or desirable in connection with the commencement, continuation, and prosecution of a Chapter 11 Case including, without limitation, the sale of any or all of the assets or stock of the Company and to file and prosecute a plan or plans of reorganization.

6. The law firm of Heller, Draper, Patrick, Horn & Dabney, LLC be, and is hereby employed to render legal services to, and to represent the Company in connection with a Chapter 11 Case and any other related matters in connection therewith, on such terms and conditions as the IC Members shall approve including, without limitation, fee structure and amount, retainer, cost reimbursement.
7. The IC Members are hereby authorized, empowered and directed for, on behalf of, and in the name of, the Company to retain and employ other attorneys, investment bankers, accountants, restructuring professionals, financial advisors, consultants, and other professionals to assist in a Chapter 11 Case on such terms and conditions as the IC Members shall approve including, without limitation, fee structure and amount, retainer, cost reimbursement.
8. In connection with the filing of a Chapter 11 Case by the Company, the IC Members are hereby authorized, empowered, and directed for, and on behalf of, and in the name of, the Company to negotiate, execute, and deliver a debtor-in-possession loan facility (including, in connection therewith, such notes, security agreements, mortgages, and other agreements or instruments or amendments or modifications thereto as the IC Members consider appropriate) on the terms and conditions as the Managers may consider necessary, proper, or desirable, such determination to be conclusively evidenced by such execution or the taking of such action, and to consummate the transactions contemplated by such agreements or instruments on behalf of the Company; and with such security instruments containing such terms and conditions including, without limitation, a confession of judgment, waivers of appraisal and notice, consent to executory process and a pact de non-aliendo.
