**ORDER GRANTING THE LIQUIDATING TRUSTEE'S SIXTH OMNIBUS MOTION

3. The Gift Card Claims identified on Exhibit B attached are hereby reclassified as General Unsecured Claims.
4. The objection to each Claim, as addressed in the Motion and as set forth on Exhibits A and B, constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each such Claim that is the subject of the

Motion. Any stay of this Order pending appeal by any claimants whose Claims are subject to this Order shall only apply to the contested matter that involves such claimant and shall not act to stay the applicability and/or finality of this Order with respect to any other contested matters addressed in the Motion and this Order.

5. The Trust and the Liquidating Trustee are authorized to take any and all actions that are necessary and appropriate to give effect to this Order.

6. This Court shall retain jurisdiction over all matters arising from or related to the interpretation and implementation of this Order.
