Order Granting Motion to Retain and Employ Donlin Recano & Company, Inc. as Claims Noticing and Solicitation Agent Pursuant to 28 U.S.C. §156(c)

This matter was heard on the motion (the "Motion") filed by Friendship Village of Mill Creek, NFP, d/b/a Greenfields of Geneva, debtor and debtor in possession herein, to retain and employ Donlin Recano & Company, Inc. as Claims Noticing and Solicitation Agent pursuant to 28 U.S.C. §156(c), and the Court, having considered the record in this case, the pleadings on file and the statements of counsel in support of their respective positions, and having afforded the parties an opportunity for hearing as was appropriate under the circumstances, and being advised in the premises:


IT IS ORDERED:

1. The Motion is GRANTED.

2. Donlin Recano & Company, Inc. is authorized pursuant to 28 U.S.C. §156(c) to act as Claims Noticing and Solicitation Agent to all creditors in this case as on the terms reflected in the Motion and the "Engagement Agreement" which is attached to the Motion as Exhibit A, with all reimbursement of costs and expenses as administrative expenses of the Debtor's case pursuant to 28 U.S.C. § 156(c) and 11 U.S.C. § 503(b)(1)(A).

3. Donlin Recano & Company, Inc. may replenish the retainer it held at the commencement of the Debtor's case to the sum of \$5,000.00, and it may hold that retain through the conclusion of the Debtor's chapter 11 case.

4. The indemnification provisions contained in paragraph 11 of the Retention Agreement between the Debtor and Donlin Recano & Company, Inc. (which is attached as Exhibit A to the Motion) shall, by the agreement of those parties, are waived by Donlin Recano & Co., Inc. and shall have no effect.
