**ORDER AND NOTICE OF HEARING ON  
ADEQUACY OF DISCLOSURE STATEMENT**

1. A disclosure statement and a plan under chapter 11 of the Bankruptcy Code having been filed by August 31, 2017, the court has set the hearing to consider the approval of the disclosure statement on **September 20, 2017 at 2:00 p.m.** in Courtroom 719, Everett McKinley Dirksen United States Courthouse, 219 South Dearborn Street, Chicago, Illinois.


2. September 18, 2017 is fixed as the last day for filing and serving, in accordance with Federal Rule of Bankruptcy Procedure 3017(a), written objections to the disclosure statement. Dearborn Street, Room 873, Chicago, IL 60604; and (d) all those persons and entities that have formally requested notice of proceedings in this case by filing a written request for notice pursuant to Bankruptcy Rule 2002 or, whose counsel has filed an appearance in this case.

3. Debtor's attorney shall serve a copy of the plan of reorganization and the disclosure statement which the Debtor filed on August 31, 2017, to the Debtor's 20 largest creditors, counsel for the Bond Trustee, the United States Trustee, the United States Attorney, and all parties which have appeared in this case and requested notice of proceedings.

4. Debtor's attorney shall serve copies of this Notice to debtor, its creditors and other parties in interest on or before **September 8, 2017**.
