1 On June 30, 2026, the Court held a hearing on the Debtors' motion to confirm the sales of
2 substantially all of the Debtors' assets after the auction held on June 24, 2026. Separate orders
3 will be entered with respect to the Court's approval of those sales. At the conclusion of the sale
4 hearing, the Court discussed with counsel for the Debtors, the Official Committee of Unsecured
5 Creditors (the "Committee"), and Conterra Agricultural Capital, LLC (the "Conterra"), and other
6 parties, the schedule for the briefing, solicitation, and hearing on a combined chapter 11 plan of
7 reorganization and disclosure statement (the "Combined Plan and Disclosure Statement") pursuant
8 to 11 U.S.C. § 105(d)(2)(B)(vi).

9 In consideration of the statements in support of the schedule proposed on the record of the
10 hearing; the adequacy of the notice of such procedures; the settlement among the Debtors, the
11 Committee, and Conterra rendering the contemplated plan consensual as among such parties; the
12 recent sale process resolving the disposition of substantially all assets of the Debtors; and good
13 and sufficient cause appearing therefor, it is hereby

14 ORDERED that:

15 1. The deadline for the Debtors to file the Combined Plan and Disclosure Statement and
16 to solicit votes is **July 10, 2026**.

17 2. The deadline for the Debtors to file a motion requesting approval of the Combined
18 Plan and Disclosure Statement, the proposed solicitation and voting procedures (the "Solicitation
19 Procedures"), and any brief in support of confirmation of the Combined Plan and Disclosure
20 Statement is **July 14, 2026**.

21 3. Any objection to the adequacy of disclosure in the Combined Plan and Disclosure
22 Statement, the Solicitation Procedures, or plan confirmation pursuant to the Combined Plan and
23 Disclosure Statement must be filed and served on counsel to the Debtors, the Committee, Conterra,
24 and the U.S. Trustee no later than **July 28, 2026**.

25 4. The deadline for the Debtors and any other party supporting the Combined Plan and
26 Disclosure Statement to file and serve a reply in support thereof is **August 4, 2026**.

1 5. The deadline for parties entitled to vote on the Combined Plan and Disclosure
2 Statement to submit ballots to accept or reject is August 5, 2026.

3 6. The deadline for the Debtors to file a voting report reflecting the tabulation of ballots
4 cast on the Combined Plan and Disclosure Statement is August 7, 2026.

5 7. A hearing on final confirmation and approval of the Combined Plan and Disclosure
6 Statement and approval of the Solicitation Procedures is scheduled for August 11, 2026 at 9:30
7 a.m. (PT) at the United States Bankruptcy Court for the Eastern District of California, Robert E.
8 Coyle United States Courthouse, 2500 Tulare Street, Fresno, CA 93721, Courtroom 13 (5th Floor).
