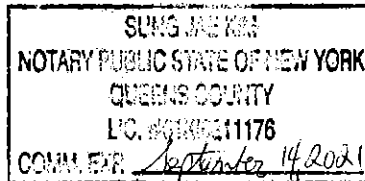
1. I am over the age of 18 years and not a party to these chapter 11 cases.
