WHEREFORE, in accordance with the Court's February 21, 2019 *Order Establishing Procedures for Interim Compensation and Reimbursement of Professionals and Official Committee Members* [Docket No. 91], the Debtors are authorized to pay R&C: (i) 80% of the fees requested in the Application (\$99,152.00) for a total of \$79,321.60; and (ii) 100% of the expenses requested in the Application in the amount of \$466.61 for a grand total of \$79,788.21.
