WHEREFORE, in accordance with the Court's February 21, 2019 *Order Establishing Procedures for Interim Compensation and Reimbursement of Professionals and Official Committee Members* [Docket No. 91], the Debtors are authorized to pay R&C: (i) 80% of the fees requested in the Application in the amount of \$164,991.00 for a total of \$131,992.80; and (ii) 100% of the expenses requested in the Application in the amount of \$2,419.55 for a grand total of \$134,412.35.
