**ORDER APPROVING FIRST INTERIM APPLICATION OF ROBINSON & COLE LLP,  
AS COUNSEL TO THE OFFICIAL COMMITTEE OF ASBESTOS PERSONAL  
INJURY CLAIMANTS, FOR PAYMENT OF INTERIM COMPENSATION AND  
REIMBURSEMENT OF EXPENSES INCURRED FOR THE PERIOD  
FEBRUARY 4, 2019 THROUGH MARCH 31, 2019**

Upon the First interim Application of Robinson & Cole LLP, as Counsel to the Official Committee of Asbestos Personal Injury Claimants for Payment of Interim Compensation and Reimbursement of Expenses Incurred for the Period February 4, 2019 through March 31, 2019 (the “Application”); it appearing that this Court has jurisdiction to consider the Application pursuant to 28 U.S.C. §§ 157 and 1334; and it appearing that venue of these chapter 11 cases and the Application in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b); and after due deliberation thereon; and good and sufficient cause appearing therefor;

IT IS HEREBY ORDERED THAT:

1. The Application is GRANTED as set forth herein.

2. In accordance with Bankruptcy Code sections 330 and 331, Bankruptcy Rule 2016 and Local Bankruptcy Rule 2016-2, the Debtors are authorized to pay Robinson & Cole LLP interim compensation in the amount of \$264,143.00 for professional services rendered on behalf of the Official Committee of Asbestos Personal Injury Claimants (the “Committee”) and reimbursement of actual and necessary expenses in the amount of \$2,886.16 less any amount already paid pursuant to the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals and Official Committee Members* [D.I. 91] (the “Compensation Order”).

3. To the extent the Application is inconsistent with the terms of this Order, the terms of this Order shall govern.

4. This Court shall retain exclusive jurisdiction over all matters pertaining to this Order and the Application.
