PLEASE TAKE NOTICE that, on August 7, 2019, the **Second Interim and Final Fee Application of Sidley Austin LLP for Allowance of Compensation and Reimbursement of Expenses for the Interim Period from April 1, 2019 to and Including July 9, 2019, and the Final Period from January 22, 2019 to and Including July 9, 2019** (the "Application"), was filed with the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court"). The Application seeks approval of (i) interim fees in the amount of \$321,435.00, and reimbursement of interim expenses in the amount of \$6,596.52; and (ii) final fees in the amount of \$1,545,259.50, and reimbursement of final expenses in the amount of \$19,456.84.
