NOTICE OF CONFIRMATION HEARING AND OBJECTION DEADLINE [Related Docket No. 72]

PLEASE TAKE NOTICE THAT on December 21, 2023, the United States Bankruptcy Court for the Southern District of Texas (the "Bankruptcy Court") entered an order [ECF # 75] (the "Disclosure Statement Approval Order")²: (a) conditionally approving the Disclosure Statement as set forth in the Debtor's Joint Chapter 11 Plan of Reorganization and Disclosure Statement (the "Plan") [ECF #11]; (b) scheduling the Confirmation Hearing; (c) approving the Solicitation Procedures with respect to the Plan, including the form of Ballots; (d) approving the form and manner of the Opt Out Notice; (e) establishing January 19, 2024, as the deadline to file objections to the Disclosure Statement or Confirmation of the Plan, the deadline to submit Opt Out Forms and Ballots in accordance with the Solicitation Procedures; and (f) granting related relief.

PLEASE TAKE FURTHER NOTICE THAT the hearing at which the Bankruptcy Court will consider to: (i) to approve the adequacy of the Disclosure Statement on a final basis; and (ii) consider Confirmation of the Plan (the "<u>Confirmation Hearing</u>") will commence on <u>January 25, 2024 at 2:00 pm</u>, prevailing Central Time, before the Honorable Christopher M. Lopez, in the United States Bankruptcy Court for the Southern District of Texas, located at 515 Rusk Street, Courtroom 401, Houston, Texas 77002.

PLEASE TAKE FURTHER NOTICE THAT the deadline for filing any responses or objections to the Plan (which includes the Disclosure Statement) is <u>January 19, 2024.</u>

PLEASE TAKE FURTHER NOTICE THAT

1. The Confirmation Hearing will be conducted in Courtroom 401, 4th Floor, 515 Rusk Avenue, Houston, TX 77002. You may participate in the Confirmation Hearing either in person or by any audio and video connection.

- 2. Audio communication will be by use of the Court's dial-in facility. You may access the facility at **(832) 917-1510**. You will be responsible for your own long-distance charges. - 3. You may view video via **GoToMeeting**. To use GoToMeeting, the Court recommends that you download the free GoToMeeting application. Once connected, click the settings icon in the upper right corner and enter your name under the personal information setting.

If a party attending virtually wants to both see the documents and exhibits as presented to the Court and hear the proceeding, the party should (1) dial in through the audio system, and (2) log into the Court's video via GoToMeeting.
- 7. Any exhibit offered by the Debtor will be filed on the Court's docket. Additionally, the Debtor may have demonstrative exhibits to aid in its presentation to the Court, copies of which may be obtained by any party by sending a request to the undersigned counsel to the Debtor at the email addresses listed below.
- 8. If any party wishes to offer exhibits, these exhibits should be filed with the Clerk of the Court using the Court's CM/ECF system. Each exhibit should be filed as a separate attachment to an Exhibit List in compliance with Bankruptcy Local Rule 9013 and General Order 2020-04.
