DEED OF RELEASE

THIS DEED OF RELEASE is made as of August 30, 2018
BETWEEN:

- (1) **OPEN ROAD FILMS, LLC**, of 12301 Wilshire Boulevard, Suite 600 Los Angeles, CA90025, United States of America ("**Chargee**" which expression shall be deemed to include its successors in title and permitted assigns); and
- (2) **2.9 FILM DISTRIBUTION LIMITED** a limited liability company registered in England & Wales (Company No. 10161619) whose registered office is at Fieldfisher Riverbank House, 2 Swan Lane, London EC4R 3TT, United Kingdom (the "**Chargor**" which expression shall be deemed to include its successors in title and permitted assigns);

IT IS AGREED as follows:

1. Definitions

In this Deed:

"**Charge**" means a deed of security assignment and charge dated **22 December 2016** made between the Chargor and the Chargee relating to the film entitled "The Untitled Playmobil Movie";

"**Distribution Collateral**" shall have the meaning given in the Charge;

"**Secured Obligations**" shall have the meaning given in the Charge; and

"**Security**" means any mortgage, charge (whether fixed or floating, legal or equitable), pledge, lien, assignment by way of security or other security interest securing any obligation of any person or any other agreement or arrangement having a similar effect.

2. Release

2.1 The Chargee hereby absolutely, irrevocably and unconditionally:

- (a) releases and discharges the Security created in its favour by the Chargor under the Charge;
- (b) releases and discharges the Chargor from all its covenants, liabilities and obligations under the Charge including without limitation the Secured Obligations and any guarantee and indemnity granted by the Chargor pursuant to the Charge; and
- (c) reassigns to the Chargor absolutely all or any part of the Distribution Collateral assigned by the Chargor by or pursuant to the Charge.

3. Further assurance

The Chargee will, at the request and cost of the Chargor, take such further action as is necessary to release or re-assign to the Chargor the property and assets subject to the Security created by the Charge.

4. Counterparts

This Deed may be executed in any number of duplicates, or by the parties on separate counterparts. Each executed duplicate or counterpart shall be an original but all the duplicates or counterparts shall together constitute one document

5. Governing law

5.1 This Deed and any non-contractual obligations arising out of or in connection with this Deed shall be governed by English Law.

5.2 The parties irrevocably submit to the exclusive jurisdiction of the courts of England to settle any dispute which may arise out of or in connection with this Deed.


