PLEASE TAKE NOTICE OF THE FOLLOWING:

1. A hearing (the “Hearing”) has been reset² to **October 5, 2023 at 10:00 a.m.** (prevailing Central Time) before the Honorable David R. Jones, United States Bankruptcy Judge, at the United States Bankruptcy Court for the Southern District of Texas (the “Court”), Courtroom 400, 4th Floor, 515 Rusk Street, Houston, Texas 77002, in connection with the following matters:

- a. *Debtors’ Emergency Motion for (a) Entry of an Order (i) Approving Bidding Procedures, (ii) Approving Procedures for the Assumption and Assignment of Executory Contracts and Unexpired Leases, (iii) Approving Stalking Horse Protections, (iv) Scheduling Bid Deadline, Auction Date and Sale Hearing Date, and (v) Approving Form of Notice Thereof; (b) Entry of an Order After the Sale Hearing (i) Authorizing the Debtors to Sell Their Assets, and (ii) Authorizing the Debtors to Assume and Assign Certain Executory Contracts and Unexpired Leases; and (c) Granting Related Relief* [ECF # 180]; and
- b. *Order (I) Modifying Bidding Procedures; (II) Continuing Sale Hearing; and (III) Granting Related Relief* [ECF # 274].
