**NOTICE OF DEBTORS' INTENT TO ASSUME
AND ASSIGN CERTAIN EXECUTORY CONTRACTS AND
UNEXPIRED LEASES AND SETTING FORTH THE CURE AMOUNTS**

PLEASE TAKE NOTICE that on July 25, 2023, Paradox Resources, LLC, *et al.*, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed with the Court their *Emergency Motion for (a) Entry of an Order (i) Approving Bidding Procedures, (ii) Approving Procedures for the Assumption and Assignment of Executory Contracts and Unexpired Leases, (iii) Approving Stalking Horse Protections, (iv) Scheduling Bid Deadline, Auction Date and Sale Hearing Date, and (v) Approving Form of Notice Thereof; (b) Entry of an Order After the Sale Hearing (i) Authorizing the Debtors to Sell Their Assets, and (ii) Authorizing the Debtors to Assume and Assign Certain Executory Contracts and Unexpired Leases; and (c) Granting Related Relief* [ECF # 180] (the “Sale Motion”).²

PLEASE TAKE FURTHER NOTICE that:

1. After the Bidding Procedures Hearing held on July 28, 2023, the Court entered the order [ECF # 207] (the “Bidding Procedures Order”), which among other things, (a) establishes bidding procedures (the “Bidding Procedures”) that govern the manner in which the Assets of the Debtors are to be marketed and sold; and (b) establishes procedures for the assumption by the Debtors and assignment to a Successful Bidder of certain of the Debtor’s executory contracts and unexpired leases pursuant to section 365 of the Bankruptcy Code (the “Assigned Contracts”).

2. A hearing (the “Sale Hearing”) shall be held before the Honorable David R. Jones, United States Bankruptcy Judge, at the United States Bankruptcy Court for the Southern District of Texas on **September 6, 2023 at 9:00 a.m. (prevailing Central Time)**, or as soon thereafter as counsel may be heard. The Debtors shall appear before the Court at the Sale Hearing and seek entry of an order: (a) authorizing the Sale of the designated Purchased Assets

by the Debtors to the Successful Bidder; (b) authorizing the assumption and assignment of the Assigned Contracts; and (c) granting certain related relief.

3. The Debtors are parties to various executory contracts and unexpired leases which may be designated by the Successful Bidder as Assigned Contracts in connection with the Sale. Pursuant to the Bidding Procedures Order, the Debtors intend to assume and assign the Assigned Contracts to the Successful Bidder upon the closing of the Sale if such executory contracts or unexpired leases are designated by the Successful Bidder as Assigned Contracts in the applicable Asset Purchase Agreement.

4. You have been identified as a counterparty to an executory contract or unexpired lease that may potentially be designated as an Assigned Contract in an Asset Purchase Agreement to be executed by the Debtors and Successful Bidder. The executory contract or unexpired lease with respect to which you have been identified as a counterparty, and the corresponding proposed cure amount (the “Cure Amount”) which the Debtors have identified, based on their books and records, as necessary to cure defaults and/or provide compensation or adequate assurance of compensation for defaults arising prior to the Petition Date are set forth on **Schedule 1** annexed hereto.

5. The Debtors believe that any and all defaults (other than the filing of the Chapter 11 Cases) and actual pecuniary losses under the Assigned Contracts can be cured by the payment of the Cure Amount.

6. If designated as an Assigned Contract by a Successful Bidder in an Asset Purchase Agreement with the Debtors, the assumption and assignment of any Assigned Contract and payment of any Cure Amount shall result in the full release and satisfaction of any claims or defaults, whether monetary or non-monetary, upon the consummation of the Sale with a Successful Bidder.

7. Pursuant to the Bidding Procedures Order, any objections to the assumption and assignment of any executory contract or unexpired lease identified in the Cure Notice or to the Cure Amounts set forth in the Cure Notice (a “Contract Objection”), must: (a) set forth in writing and describe with specificity the factual and legal basis for the Contract Objection; (b) comply with the Bankruptcy Rules and Bankruptcy Local Rules; and (c) be filed with the Clerk of the Court no later than **5:00 p.m. (prevailing Central Time) on August 28, 2023** (the “Objection Deadline”).

8. If a counterparty to an executory contract or unexpired lease set forth on Schedule 1 of this Cure Notice fails to file a Contract Objection by the Objection Deadline, then the Cure Amount set forth in this Cure Notice will be binding upon the contract counterparty, and all parties in interest, for all purposes in the Chapter 11 Cases and otherwise. All such counterparties to those executory contracts and unexpired leases on Schedule 1 of this Cure Notice will: (a) be forever barred from objecting to the Cure Amounts with respect to such executory contracts and unexpired leases; (b) be deemed to have consented to the assumption and assignment if the Successful Bidder designates such contract or lease as an Assigned Contract; and (c) be forever barred and estopped from asserting or claiming against the Debtors or Successful Bidder, as applicable, that any additional amounts are due, other defaults exist, other conditions to

assignment must be satisfied under such executory contracts or unexpired leases, or that there is any objection or defense to the assumption and assignment.

9. If a counterparty to an executory contract or unexpired lease set forth on Schedule 1 of this Cure Notice timely files a Contract Objection, whether based on Cure Amount or any other alleged cause or claim, then, to the extent the relevant parties are unable to resolve the Contract Objection prior to the commencement of the Sale Hearing, such Contract Objection will be adjudicated at the Sale Hearing or at such other date and time as may be fixed by the Court.

10. The Successful Bidder shall be responsible for satisfying any requirements regarding adequate assurance of future performance that may be imposed under sections 365(b) and (f) of the Bankruptcy Code in connection with the proposed assignment of your Assigned Contract. The Court shall make its determinations concerning such adequate assurance of future performance pursuant to sections 365(b) and (f) of the Bankruptcy Code at the Sale Hearing. If any counterparty to an Assigned Contract objects on adequate assurance of future performance grounds to the assumption and assignment of its Assigned Contract (an “Adequate Assurance Objection”), such counterparty must file the Adequate Assurance Objection no later than the Objection Deadline (as defined herein) of **5:00 p.m. (prevailing Central Time) on September 4, 2023**. The Court shall make any and all determinations concerning adequate assurance of future performance under the Assigned Contracts pursuant to sections 365(b) and (f) of the Bankruptcy Code at the Sale Hearing. Any counterparty failing to timely file an Adequate Assurance Objection shall be forever barred from objecting to assumption by the Debtor and assignment to the Successful Bidder of the relevant Assigned Contract on grounds of adequate assurance of future performance.

11. If at any time after this Cure Notice is served (but prior to the Sale pursuant to any Asset Purchase Agreement) the Debtors: (a) amend Schedule 1 to this Cure Notice and include additional executory contracts or unexpired leases; or (b) receive notice from the Successful Bidder that additional prepetition executory contracts or unexpired leases are to be designated as Assigned Contracts under the Asset Purchase Agreement, then the Debtors shall serve a supplemental cure notice (a “Supplemental Cure Notice”) by first class mail, facsimile, electronic transmission, or overnight mail on the contract counterparty (and its attorney, if known) to each such contract (a “Previously Omitted Contract”) within three (3) business days of the receipt of notice of designation as an Assigned Contract.

12. Unless the contract counterparty to the Previously Omitted Contract properly files a Contract Objection to the Supplemental Cure Notice within fourteen (14) days of service of the Supplemental Cure Notice, the Debtors shall obtain an order of the Court fixing the applicable Cure Amounts and approving the assumption and assignment of the Previously Omitted Contract as an Assigned Contract. If a Contract Objection is timely filed and served with respect to a Previously Omitted Contract, and the relevant parties are unable to resolve the Contract Objection, such Contract Objection will be adjudicated at the Sale Hearing or, if the Sale Hearing date has passed, at such other date and time as may be fixed by the Court.

13. For the avoidance of doubt, the inclusion of an executory contract or unexpired lease on Schedule 1 to this Cure Notice shall not obligate the Debtors to assume and assign any executory contract or unexpired lease listed thereon. The rights of the Debtors or Successful Bidder to modify the list of Assigned Contracts, including to remove any contracts or leases from

such list, are expressly reserved. Only those executory contracts and unexpired leases designated as Assigned Contracts at closing will be assumed and assigned to the Successful Bidder. To the extent your executory contract or unexpired lease is not designated as an Assigned Contract, the Debtors intend to seek an order from the Court at the Sale Hearing rejecting such contract or lease pursuant to section 365 of the Bankruptcy Code.

14. If no Cure Amount is due under the executory contract or unexpired lease, and the contract counterparty does not otherwise object to the assumption and assignment, then no further action needs to be taken on the part of that counterparty.

15. The Debtors' decision to assume and assign the Assigned Contracts is subject to Court approval and consummation of the Sale. Absent consummation of the Sale, each Assigned Contract shall not be deemed assumed or assigned, and shall be subject to further administration under the Bankruptcy Code in all respects. The designation of any agreement as an Assigned Contract shall not constitute or be deemed to be a determination or admission by the Debtors that such document is, in fact, an executory contract or unexpired lease within the meaning of the Bankruptcy Code (all rights with respect thereto being expressly reserved).

16. This Cure Notice is subject to the full terms and conditions of the Sale Motion and the Bidding Procedures Order, which shall control in the event of any conflict, and the Debtor encourages all parties in interest to review such documents in their entirety.
