Dear Counsel:

We are counsel to ACTEGA Kelstar, Inc. (the "Seller") and have been authorized to send this reclamation notice (the "Reclamation Notice") on its behalf.

Pursuant to Section 2-702 of the Uniform Commercial Code and Section 546(c) of the United States Bankruptcy Code, Seller hereby formally demands reclamation of the goods (the "Goods") delivered by the Seller to Quebecor and or any of its affiliated debtors (individually or collectively, the "Debtor") within forty-five (45) days before the filing of the chapter 11 bankruptcy petition by the Debtor on January 21, 2008 (the "Petition Date"). The Goods are more particularly described in the spreadsheets attached hereto. This demand is served not later than twenty (20) days after the Petition Date with respect to Goods that were received by the Debtor not earlier than forty-five (45) days prior to the Petition Date, in accordance with Section 546(c) of the United States Bankruptcy Code.

In light of your recent bankruptcy filing, you are notified that all Goods subject to our right of reclamation must be protected and segregated by you and shall not be used for any purpose whatsoever except those specifically authorized following notice and a hearing by the Bankruptcy Court.

Seller further reserves the right to amend and supplement this Reclamation Notice (including filing additional evidence in support of this Reclamation Notice) or to file additional reclamation notices or claims; including without limitation, all other claims at law or in equity. Seller also reserves all rights accruing to it, and the filing of this Reclamation Notice is not intended to be and shall not be construed as: (1) an election of remedy; (2) a waiver of any past present or future defaults or events of default; or (3) a waiver or limitation of any rights of Seller, including the Seller's right to assert an administrative claim pursuant to Section 503(b)(9) of the Bankruptcy Code.
