**AMENDED VERIFIED STATEMENT OF HOGAN & HARTSON LLP
 PURSUANT TO FEDERAL RULE OF BANKRUPTCY PROCEDURE 2019**

4. Hogan & Hartson's representation of the Local Insight Entities commenced in the above-captioned chapter 11 cases subsequent to the date of the Original Statement.

5. The Abitibi Entities have unsecured claims against one or more of the Debtors in excess of \$31,000,000.00, based on goods sold and/or delivered to one or more of the Debtors prior to the commencement of the above-captioned cases. The Abitibi Entities have reclamation claims and/or administrative expense claims against one or more of the Debtors pursuant to sections 546(c) and 503(b)(9) of title 11 of the United States Code.

6. Upon information and belief, the Local Insight Entities are each a party to one or more executory contracts with one or more of the Debtors.

7. Hogan & Hartson renders legal services to one or more of the above-named creditors and/or parties-in-interest on a regular basis in matters preceding and unrelated to the above-captioned Chapter 11 cases.

8. Hogan & Hartson has been retained by each of the above-named creditors and/or parties-in-interest to serve as its counsel and represent its interests in the above-captioned chapter 11 cases.

9. Upon information and belief, neither Hogan & Hartson, nor the undersigned attorney, owns or has ever owned, any claim against the Debtors in the above-captioned chapter 11 cases, nor any interest in the Debtors.
