**NOTICE OF FILING OF ADDENDUM TO MARCH 20, 2008 ENGAGEMENT LETTER
BETWEEN DEBTORS AND KPMG LLP (US)**

PLEASE TAKE NOTICE that pursuant to the Court's April 17, 2008 Order Authorizing the Debtors to Employ KPMG LLP (US) *nunc pro tunc* to April 7, 2008 as Tax Compliance and Tax Consulting Advisors to the Debtors Pursuant to Sections 327(a) and 328(a) of the Bankruptcy Code (Docket No. 569) (the "Order"), KPMG LLP (US) ("KPMG US") was retained by the Debtors as a tax compliance and tax consulting advisor;

PLEASE TAKE FURTHER NOTICE that, as set forth in the Declaration of Michael Lawler in support of the Debtors' application (the "Application") to retain KPMG US, KPMG

US agreed to provide additional tax compliance and/or consulting services as necessary or desirable and as agreed to between the Debtors and KPMG US, and, to the extent that the Debtors and KPMG US determined that additional engagement letters were necessary in furtherance of the services for which KPMG US was retained pursuant to the Order, the Debtors and KPMG US agreed to file any such additional engagement letters with the Bankruptcy Court;

PLEASE TAKE FURTHER NOTICE that, attached hereto is an addendum to the previously approved March 20, 2008 engagement letter entered into between Quebecor World (USA), Inc. ("QWUSA") and KPMG US. The addendum provides for KPMG US to prepare federal and state income tax returns for the year 2007 for three (3) additional affiliates of QWUSA, which services are to be provided at the same rates and upon the same Terms and Conditions approved by the Bankruptcy Court in connection with KPMG US's retention pursuant to the Order. Fees related to the work described in the addendum are included within the initial cap described in the Application.
