PLEASE TAKE FURTHER NOTICE that, attached hereto is an additional engagement letter entered into between Quebecor World (USA), Inc. and KPMG Canada for tax consulting services with respect to various US tax projects and restructuring initiatives, which services are to be provided at the same rates and upon the same Terms and Conditions approved by the Bankruptcy Court in connection with KPMG Canada's retention pursuant to the Order.
