5. That I have not been the subject of disciplinary action by the bar or courts of any jurisdiction during the preceding five (5) years.


6. That I have not appeared *Pro Hac Vice* within this state within the immediate preceding twelve (12) months.

9. That I have not engaged in the general practice of law in this State without being properly admitted and licensed to practice law in this State.

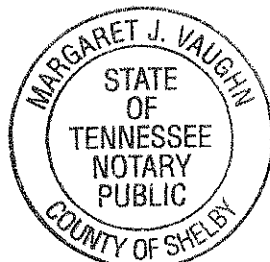
