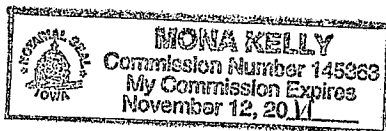
8. That I do not maintain an office within this State.


9. That I have not engaged in the general practice of law in this State without being properly admitted and licensed to practice law in this State.
