AGREEMENT AMONG THE REORGANIZED DEBTORS, THE UNITED
STATES, THE STATE OF ILLINOIS, THE KEYSTONE PRP GROUP, LENZ
PRP GROUP AND RINGIER A.G; AND (II) ASSUMPTION OF THE
SPECIFIED ENVIRONMENTAL CONTRACTS, AS MODIFIED**

PLEASE TAKE NOTICE THAT:

1. On August 20, 2010, the Reorganized Debtors filed the Reorganized Debtors' Motion Pursuant to Federal Rule of Bankruptcy Procedure 9019 Seeking Approval of (I) the Settlement Agreement Among the Reorganized Debtors, the United States, the State Of Illinois, the Keystone Prp Group, Lenz Prp Group and Ringier A.G; And (II) Assumption of the Specified Environmental Contracts, as Modified (the "**Environmental Motion**").

Rosenberg, Esq. and Elizabeth R. McColm, Esq.).

4. **Objection Deadline:** Any **Objections** must be filed with the Court and served on the parties listed above so that such **Objections** are *actually received* by the **Notice Parties** by **4:00 p.m. Eastern Time on September 13, 2010.**
