**NOTICE OF MOTION TO COMPEL REORGANIZED DEBTOR TO ESTABLISH
CLASS 3 DISTRIBUTION RESERVE**

PLEASE TAKE NOTICE that a hearing (the “Hearing”) to consider the attached motion dated December 16, 2010 (the “Motion”) of Riverside Claims, LLC (“Riverside”), seeking entry of an order compelling the above-captioned confirmed debtors (collectively, the “Debtors”) to establish a Distribution Reserve pursuant to Section 8.10 of the *Modified Third Amended Joint Plan of Reorganization of Quebecor World (USA) Inc. and Certain Affiliated Debtors and Debtors-in-Possession*, dated July 1, 2009 (the “Plan”), shall be held before the Honorable James M.
