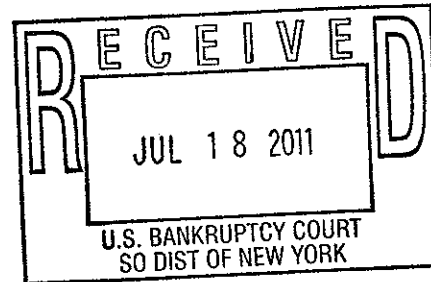

Re: Quebecor World (USA), inc. et al, Bankruptcy Case #08-10152-SHL

Dear Lady and Gentlemen:

I am in receipt of several pieces of recent correspondence regarding the Quebecor bankruptcy settlement. I am listed as owing money to the settlement based on preferential payments. I spoke with a female in the ASK office last March, 2010, and I believe it was Lauren Porter although my notes from this conversation are in storage so perhaps you can check your records. At that time I explained our situation with Quebecor and thought the matter was resolved except for any nominal settlement amount we might receive when the matter is closed.

The details are as follows. Putman, Inc. d/b/a A-1 STAFFING bought certain assets and accounts from Professional Resources, Inc. (PRI) on May 1, 2007. At that time Quebecor was a customer of PRI and we wished to continue to do business with Quebecor. We requested a signed sales proposal which included terms and conditions of sale and a credit application and they failed to comply. Therefore, we were unable to establish commercial credit for their account without the information and a signed agreement on our terms of sale.

For the next eight months we sold them on a pay as you go basis with checks coming in and services then rendered. When they stopped payment on a check in February, 2008 we ceased to do business with them entirely. Shortly thereafter we were notified of their bankruptcy and submitted our balance which we wrote off later that year not expecting a recovery.

Ms. Porter told me should understood this arrangement and that we would be removed from the list of hundreds of creditors for Quebecor. I am surprised this is resurfacing again as we thought the matter resolved except for, perhaps a pennies on the dollar unsecured creditor payment by now. We wish to contest that we owe Quebecor, ASK Financial or the bankruptcy any money on this account.

As a side note, Putman, Inc. no longer owns A-1 STAFFING, certain assets and accounts were sold recently. Further, Professional Resources, Inc. is no longer in business, and A-1 Staffing, Inc. is not a corporate name that was ever used nor registered by Bruce J. Putman, owner of Putman, Inc.
