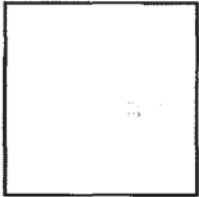
Hi Gabe,

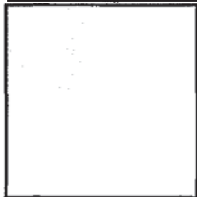
Hi Gabe,
