PLEASE TAKE NOTICE that on February 19, 2024, Trinitas Advantaged Agriculture Partners IV, LP and certain of its affiliates that are debtors and debtors in possession (collectively, the “Debtors”) in the above-captioned chapter 11 bankruptcy cases (the “Chapter 11 Cases”), each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code with the United States Bankruptcy Court for the Northern District of California (the “Bankruptcy Court”).

PLEASE TAKE FURTHER NOTICE that by order dated August 5, 2026 (the “Solicitation Procedures Order”), the Bankruptcy Court has approved the *Disclosure Statement for Joint Chapter 11 Plan of Liquidation dated August 4, 2026* (as may be amended, together with any attachments, schedules, or exhibits thereto, the “Disclosure Statement”), as containing adequate information within the meaning of section 1125 of Bankruptcy Code and approved certain procedures (collectively, the “Solicitation Procedures”) for the solicitation and tabulation of votes to accept or reject the *Joint Chapter 11 Plan of Liquidation dated August 4, 2026* (as may be amended, supplemented, or modified, together with any attachments, schedules, or exhibits thereto, the “Plan”), jointly proposed by the Debtors and the official committee of unsecured creditors appointed in the Chapter 11 Cases (the “Committee,” and, together with the Debtors, the “Plan Proponents”), and scheduled a hearing on confirmation of the Plan.²

PLEASE TAKE FURTHER NOTICE that, pursuant to the Solicitation Procedures Order, the Bankruptcy Court established **August 31, 2026**, as the last day by which a Ballot accepting or rejecting the Plan must be received by the Claims and Noticing Agent.

PLEASE TAKE FURTHER NOTICE that parties that did not receive a Ballot are not entitled to vote on the Plan.

PLEASE TAKE FURTHER NOTICE that a party that seeks to challenge the amount or classification of its claim or interest for voting purposes, pursuant to Rule 3018(a) of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), must file a motion (a “Rule 3018 Motion”) for an order temporarily allowing its claim in an amount for purposes of voting on the Plan and serve such motion on the Plan Proponents so that it is received by **August 31, 2026**. The request for relief sought in such Rule 3018 Motion will be heard at the Confirmation Hearing (as defined below).

PLEASE TAKE FURTHER NOTICE that on **September 18, 2026, at 11:00 a.m. (Pacific Time)**, a hearing will be held before the Honorable Dennis Montali, United States

1 Bankruptcy Judge, to consider confirmation of the Plan (the “Confirmation Hearing”). Pursuant
2 to the *Procedures for Noticing and Conducting Hearings in the San Francisco Division of the*
3 *United States Bankruptcy Court for the Northern District of California (effective May 9, 2025)*,
4 **you may participate in this hearing in-person or by Zoom**. To attend in-person, you should
5 arrive at Courtroom 17, 450 Golden Gate Avenue, 16th Floor, San Francisco, CA no later than the
6 time set forth in this notice. To attend via Zoom, please consult the court’s website, which provides
7 information explaining how to arrange an appearance at a video hearing. If you have questions
8 about how to participate in a hearing, you may contact the court by calling 888-821-7606 or by
9 using the Live Chat feature on the court’s website.

10 **PLEASE TAKE FURTHER NOTICE** that the Confirmation Hearing may be adjourned
11 from time to time, without further notice. The Plan may be modified in accordance with its own
12 provisions, the Bankruptcy Code, the Bankruptcy Rules, and any other applicable law, without
13 further notice, prior to or as a result of the Confirmation Hearing.

14 **PLEASE TAKE FURTHER NOTICE** that objections, if any, to confirmation of the Plan
15 must (a) be in writing; (b) state the name and address of the objecting party and the nature of the
16 claim or interest of such party; (c) state with particularity the basis and nature of any objection;
17 and (d) be filed with the Bankruptcy Court **no later than August 31, 2026**, and served on counsel
18 for the Plan Proponents at the above-captioned addresses. The Bankruptcy Court shall hold a
19 status conference on **September 4, 2026, at 10:00 a.m. (Pacific Time)** (the “Status Conference”)
20 to discuss any Confirmation Objections, the schedule for any further briefing by the Plan
21 Proponents or any party filing a Confirmation Objection, and the conduct of the Confirmation
22 Hearing. You may participate in the Status Conference in-person or by Zoom.

23 **PLEASE TAKE FURTHER NOTICE** that, in accordance with Bankruptcy Rule
24 3017(a), requests for copies of the Plan and Disclosure Statement (at the Plan Proponents’ expense)
