**NOTICE OF MOTION,  
RESPONSE DEADLINE AND HEARING**

Wordsworth Academy, the above captioned debtors and debtors in possession (the “Debtors”) have filed a Motion for Entry of an Order on an Emergency Basis (1) Enforcing the Automatic Stay as to Vee Galaxy, LLC and Khaled A. Baki and (2) Imposing Sanctions for Violation of the Stay (the “Motion”) with the Court.

Your rights may be affected. You should read these papers carefully and discuss them with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult an attorney.)

An expedited hearing on the Motion is scheduled to be held before the Honorable Ashely M. Chan, on **July 18, 2017, at 1:00 p.m.** at the United States Bankruptcy Court, Courtroom #5, 900 Market Street, Philadelphia, Pennsylvania, 19107.

1. If you do not want the court to grant the relief sought in the Motion or if you want the court to consider your views on the Motion, then you or your attorney must:

- (a) file an answer or objection explaining your position with the bankruptcy clerks’ office at the United States Bankruptcy Court for the Eastern District of Pennsylvania, 900 Market Street., Suite 400, Philadelphia, PA 19107 before the start of the Expedited Hearing on July 18, 2017; or
- (b) appear at the Expedited Hearing on July 18, 2017 and either
  - i. file an answer or objection explaining your position by delivering it to the court, or
  - ii. orally present an answer or objection explaining your position.
