**DECLARATION OF S. JASON TEELE IN SUPPORT OF THE APPLICATION OF THE
OFFICIAL COMMITTEE OF UNSECURED CREDITORS FOR AN ORDER
AUTHORIZING AND APPROVING THE EMPLOYMENT AND RETENTION OF
CULLEN AND DYKMAN LLP AS ITS COUNSEL EFFECTIVE AS OF JULY 17, 2017**

S. Jason Teele hereby declares, pursuant to 28 U.S.C. § 1746, as follows:

1. I am a partner of the law firm of Cullen and Dykman LLP (“**Cullen and Dykman**”), which maintains offices for the practice of law in various locations, including One Riverfront Plaza, Newark, New Jersey 07102. I am an attorney at law, duly admitted and a member in good standing of the bars of the States of New Jersey and New York. My application to appear *pro hac vice* in these cases was filed with the Court on July 25, 2017 (Docket No. 138).

2. This Declaration is submitted in support of the application (the “**Application**”) of the Official Committee of Unsecured Creditors (the “**Committee**”) appointed in the bankruptcy cases (the “**Chapter 11 Cases**”) of the above-captioned debtors and debtors- in-possession (collectively, the “**Debtors**”) for entry of an order authorizing and approving the Committee’s employment and retention of Cullen and Dykman as lead counsel to the Committee, effective as of July 17, 2017.

3. The professional services that Cullen and Dykman will provide to the Committee include, but are not limited to:

- (a) advising the Committee with respect to its rights, duties, and powers in these Chapter 11 Cases;
- (b) assisting and advising the Committee in its consultations with the Debtors relative to the administration of these Chapter 11 Cases;
- (c) assisting the Committee in analyzing the claims of the Debtors' creditors and the Debtors' capital structure and in negotiating with holders of claims and equity interests;
- (d) assisting the Committee in its investigation of the acts, conduct, assets, liabilities, and financial condition of the Debtors and of the operation of the Debtors' businesses;
- (e) assisting the Committee in its investigation of the liens and claims of the holders of the Debtors' pre-petition debt and the prosecution of any claims or causes of action revealed by such investigation;
- (f) assisting the Committee in its analysis of, and negotiations with, the Debtors or any third party concerning matters related to, among other things, the assumption or rejection of certain leases of nonresidential real property and executory contracts, asset dispositions, sale of assets, financing of other transactions and the terms of one or more plans of reorganization for the Debtors and accompanying disclosure statements and related plan documents;
- (g) assisting and advising the Committee as to its communications to unsecured creditors regarding significant matters in these Chapter 11 Cases;
- (h) representing the Committee at hearings and other proceedings;
- (i) reviewing and analyzing applications, orders, statements of operations, and schedules filed with the Court and advise the Committee as to their propriety;
- (j) assisting the Committee in preparing pleadings and applications as may be necessary in furtherance of the Committee's interests and objectives;
- (k) preparing, on behalf of the Committee, any pleadings, including without limitation, motions, memoranda, complaints, adversary complaints, objections, or comments in connection with any of the foregoing; and

- (1) performing such other legal services as may be required or are otherwise deemed to be in the interests of the Committee in accordance with the Committee's powers and duties as set forth in the Bankruptcy Code, Bankruptcy Rules, or other applicable law.

4. As of the date of this Declaration, Cullen and Dykman has not received a retainer or any other form of compensation in connection with its proposed representation of the Committee in these Chapter 11 Cases.

5. Subject to the Court's approval and pursuant to sections 328, 330 and 331 of the Bankruptcy Code, the Bankruptcy Rules, the rules and other procedures which this Court may fix, and the Guidelines promulgated by the United States Trustee, the Committee requests that Cullen and Dykman be compensated on an hourly basis, plus reimbursement of the actual and necessary expenses that Cullen and Dykman incurs in accordance with the ordinary and customary rates which are in effect on the date the services are rendered.

6. Cullen and Dykman's current standard hourly rates are:

Partners:	\$350.00 - \$715.00 ²
Associates:	\$225.00 - \$450.00
Paralegals:	\$90.00 - \$175.00

7. The hourly charges set forth above are based upon the experience and expertise of the attorney or legal assistant involved. The hourly rates are subject to periodic annual adjustments to reflect economic and other conditions. Cullen and Dykman will advise the Committee, the Debtors, and the United States Trustee of any increases in its hourly rates.

8. Cullen and Dykman has agreed to discount its hourly rates by twenty percent (20%) as a courtesy to the Committee. Additionally, Cullen and Dykman has agreed with the

Committee that it will not charge for non- working travel time or the expenses of travel in connection with appearing at hearings before the Bankruptcy Court, the section 341(a) meeting, or meetings with the Debtors and their professionals in Philadelphia, Pennsylvania.

9. Cullen and Dykman's disbursement policies pass through all out-of-pocket expenses at actual cost. These expenses include photocopying, express or overnight delivery charges, facsimiles, toll calls, overtime meals, computerized research, deliveries, court costs, transcript fees, clerk fees, certain secretarial and other overtime expenses, and other expenses.

10. In connection with its proposed retention by the Committee in these Chapter 11 Cases, Cullen and Dykman undertook to determine whether it had any contacts or other relationships that might cause it not to be disinterested or to hold or represent an interest adverse to the Debtors' estates with respect to the matters on which it will be engaged. Cullen and Dykman obtained the names of individuals and entities that may be parties in interest in these Chapter 11 Cases from the Debtors and such parties are listed on Schedule 1 attached hereto (the "**Interested Parties List**"). Cullen and Dykman has searched on its electronic database for its connections to the entities listed on the Interested Parties List.

11. Attached hereto as Schedule 2 is a list of parties who appear on the Interested Parties List who Cullen and Dykman may currently represent or previously represented on matters wholly unrelated to these Chapter 11 Cases.

12. To the best of my knowledge, none of the entities from the Interested Parties List that appear on Schedule 2 represent one percent (1%) or more of Cullen and Dykman's gross revenue in calendar years 2015, 2016 or calendar year to date for 2017, except as otherwise disclosed on Schedule 2.

13. Except as disclosed herein, neither I, Cullen and Dykman, nor any member, counsel, or associate thereof, insofar as I have been able to ascertain, have any connection with the Debtors, their creditors, or any other parties in interest, their respective attorneys and accountants, the United States Trustee for the Region 3, any person employed in the Office of the United States Trustee for the Eastern District of Pennsylvania, or any Bankruptcy Judge currently serving on the United States Bankruptcy Court for the Eastern District of Pennsylvania. Cullen and Dykman will continue to update these disclosures as necessary.

14. Cullen and Dykman does not represent the Debtors or any of the current officers and members of the Debtors' Boards of Trustees that are identified on the Interested Parties List.

15. The proposed employment of Cullen and Dykman is not prohibited by, or improper under, Bankruptcy Rule 5002. Cullen and Dykman and the professionals it employs are qualified to represent the Committee in matters for which Cullen and Dykman is proposed to be employed.

16. To the best of my knowledge, after diligent inquiry, Cullen and Dykman is a "disinterested person" as that term is defined in section 101(14) of the Bankruptcy Code, as Cullen and Dykman, its partners, counsel, and associates (a) are not creditors, equity security holders, or insiders of the Debtors; (b) are not and were not, within two (2) years before the date of the filing of the Debtors' chapter 11 petitions, a director, officer, or employee of the Debtors; and (c) do not represent or hold an interest adverse to the interests of the Debtors' estates with respect to the matters in which Cullen and Dykman is proposed to be employed.

17. Cullen and Dykman, which employs approximately 200 attorneys, has a large and diversified legal practice that encompasses the representation of, and representations adverse to,

many entities and individuals, some of which are or may consider themselves to be creditors or parties in interest in the Chapter 11 Cases, or otherwise to have interests in these cases.

18. In addition, due to Cullen and Dykman's diverse clientele, Cullen and Dykman likely represents, and may in the future represent, creditors of the Debtors or their affiliates who have not yet been disclosed by the Debtors, in matters unrelated to the Debtors, their affiliates, or these Chapter 11 Cases.

19. Cullen and Dykman, from time to time, may work with, represent, engage, and receive referrals from the attorneys and financial advisors or consultants retained by the Debtors, the Committee, or creditors of the Debtors.

20. Cullen and Dykman will not represent any person or entity other than the Committee in matters related to these Chapter 11 Cases.

21. No promises have been received by Cullen and Dykman or any partner, counsel, or associate thereof as to payment or compensation in connection with these Chapter 11 Cases other than in accordance with the provisions of the Bankruptcy Code. Cullen and Dykman has no agreement with any other entity to share any compensation received by Cullen and Dykman in connection with these Chapter 11 Cases.

22. By separate application, the Committee is seeking the entry of an order approving the retention of Weir & Partners LLP to serve as its Pennsylvania co-counsel. Cullen and Dykman has discussed the division of responsibilities with co-counsel and will make every effort to avoid duplication of efforts in connection with these Chapter 11 Cases.

23. The foregoing constitutes the statement of Cullen and Dykman pursuant to Bankruptcy Rule 2014.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.
