**NOTICE OF MOTION, RESPONSE DEADLINE AND HEARING
DATE FOR THE MOTION OF DEBTORS FOR ENTRY OF AN ORDER
AUTHORIZING ASSUMPTION OF A CONTRACT REGARDING BREAKFAST
AND LUNCH SERVICE WITH UPPER DUBLIN SCHOOL DISTRICT**

PLEASE TAKE NOTICE that on September 25, 2017, the above-captioned debtors (the “Debtors”) filed a Motion For Entry Of An Order Authorizing Assumption Of A Contract Regarding Breakfast and Lunch Service With Upper Dublin School District with the Court seeking an entry of Order granting Debtors’ Motion.

Your rights may be affected. You should read these papers carefully and discuss them with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult an attorney.)

1. If you do not want the Court to grant the relief sought in the motion, or if you want the Court to consider your views on the Motion, then on or before **October 16, 2017**, you or your attorney must do all of the following:

- a) File an Objection to explain your position at the U.S. Bankruptcy Court, Clerk’s Office, Room 400, 900 Market Street, Philadelphia, Pennsylvania, 19107. If you mail your Objection to the Bankruptcy Clerk’s Office for filing, you must mail it early enough so that it will be received on or before the date and time stated above; and

2. If you or your attorney do not take the steps described in Paragraphs 1(a) and 1(b) above, the Court may enter an Order granting relief requested in the Motion.

3. A hearing on the Motion is scheduled to be held before the Honorable Ashely M. Chan, on **November 1, 2017 at 11:00 a.m.** at the United States Bankruptcy Court, Courtroom #5, 900 Market Street, Philadelphia, Pennsylvania 19107.
