4) If a copy of the Motion is not enclosed, a copy will be provided to you if you request a copy from the attorney named in Paragraph 1(b).

5) You may contact the Bankruptcy Court Clerk's Office at (215) 408-2800 to find out whether the hearing has been cancelled because no one filed an Objection.
